## SHIRK BEQUEST NAMES OCCF

George H. Shirk, mayor, historian, lawyer and civic leader, was an early friend of Community Foundation. In 1970, less than a year after the Foundation was established, he wrote:

"I feel that it is imperative that I be a part of this project; and, in the years ahead I hope to participate more generously."


Patricipate, he did. George established the "Carrie Shirk Fund" in memory of his mother, and he stipulated the income be used for the community's best interest.

That same year he was instrumental in developing an Endowment Fund for the Oklahoma Westerners Indian Territory Posse.

George explained:

"Throughout the Western Hemisphere, and with groups in England and Western Europe, there is a loosely knit organization of Western history buffs known as Westerners. Each local "chapter" is known as a Posse, Each Posse has its own particular projects such as erecting historical markers, publishing booklets and pamphlets on Western history, and the like.

Here in Oklahoma City we have the Indian Territory Posse of Oklahoma Westerners, It is composed of membership throughout the state; and is the only active Posse in Oklahoma. Typical members are John Kirkpatrick, Paul Strasbaugh and myself."



"I am sure you agree with me that nothing contributes more to permanency and stability than does a nest egg, that because of its existence our Possee will always be certain to have the resources for projects of worth... I would like to propose to you this plan to make the Indian Territory Posse Endowment Fund a substantial and worthwhile project, with earning sufficient to permit future Sheriffs to build our Posse into one of the finest in the nation." (February, 1972)

In 1973, Mayor Shirk established a special fund in honor of Dr. Muriel H. Wright upon her retirement from the Oklahoma Historical Society as editor of the "The Chronicles of Oklahoma". Gifts to the fund have been made by friends and admirers of Dr. Wright. The earnings provide an annual award not in excess of \$300 to the author of the best article appearing during the year in *The Chronicles*.

As late as Christmas, 1976, Shirk, working from his bed at home, facilitated the termination of the H. E. Bailey Foundation, which conveyed its remaining assets to the Community Foundation after meeting an obligation to Mercy Hospital.

George Shirk's Last Will and Testament read in part:

"I give, devise, and bequeath all the rest and remaining real estate ... including oil and gas leases ... to the Oklahoma City Community Foundation, Inc. ... The beneficiaries ... shall be:

(a) Oklahoma City University 20%
(b) Oklahoma Heritage Association 25%
(c) Oklahoma City Council of Camp Fire Girls 15%
(d) The Salvation Army... for its use exclusively in Oklahoma City 15%
(e) Mercy Hospital 25%

Should any of the above beneficiaries not be in existence at the time of my death, or should any be ineligible for any reason to be a beneficiary, then the Foundation may substitute a successor entity and if there not be such a successor entity in existence, then ... the Trustees shall add that portion pro tanto to the share of the other beneficiaries."

# Lee Earns \$7,500 For Community Foundation And Mercy



The Oklahoma City Community Foundation and Mercy Health Center are the beneficiaries of a Business Development Program sponsored by the Liberty National Bank.

\$7,500 worth of points were earned by Bank Director, Robert E. Lee. Lee, who is also chairman of the Mercy Health Center Board of Trustees, chose to divide his contribution between the Community Foundation Mercy Endowment Fund and the Health Center.

Nancy M. Berry, Executive Director of the Oklahoma City Community Foundation, attended the National Council on Foundations' 28th Annual Conference in St. Louis, May 3-6. Workshops focused on revitalizing our communities, investment management, new federal regulations, corporations and philanthropy, foundation management and office systems. The Annual Conference is open to trustees and professional personnel of grantmaking foundations, to representatives of corporations with charitable giving programs, and bank trust officers. The Community Foundation is a member of the National Council on Foundations.

In June Ms. Berry attended the Wharton School (University of Pennsylvania) Seminar "Fundamentals of Finance and Accounting for the Non-Financial Executive" which was held in Dallas. The three-day intensive program covered the major areas of a graduate business school curriculum.
