# A MESSAGE FROM THE PRESIDENT

How do I evaluate the OCCF now, ten years after my participation in its origin and in its operation? Such an evaluation can be made in rather simple terms as to what this service has rendered to me:

- 1. The objective of consistent support on a continuing basis not affected by my year-to-year fluctuation in my contributions, nor by my death;
- 2. The objective of adding worthy charities with confidence and knowing that support for those that become undesirable will be discontinued:
  - 3. The objective of surveillance over the charities helpful vigilence with financial support; and
  - 4. The objective of giving me the most for my money.

Through our fiscal committee, our trustees, and our excellent director, and through the assurance of the integrity of their successors, I am satisfied and recommend it to others with comparable incentives and objectives.

## A GUEST EDITORIAL

In 1975, Dr. & Mrs. George Bozalis established an Individual Fund in their names, designating the earnings for the Allergy Research Endowment Fund in the Community Foundation. In this guest editorial, Dr. Bozalis shares his thoughts and dreams for developing a Section of Immunology in the College of Medicine at the University of Oklahoma Health Sciences Center.

No single entity is doing so much for so many worthy causes in our city as the Oklahoma City Community Foundation. My wife and I were so impressed with the objectives of the various funds created by the Founding Fathers of the Foundation that we decided to make our personal contribution to the welfare of humanity through and with these philanthropists.

In January of 1975, through a unitrust naming the Community Foundation as final beneficiary, we established the Allergy Research Fund, with the intent that this Fund be the beginning of the financial base needed to create a Section of Immunology in the College of Medicine at the University of Oklahoma Health Sciences Center.

As an immunologist, I know that abnormalities in the immune system cause rheumatoid arthritis, systemic lupus erythematosis, asthma, and certain cancers. Scientists hope that these "unconquerable diseases of man" will be conquered in the field of immunology.

Here in Oklahoma City we have the human resources to make major contributions in this field. In Dr Solomon Papper, Distinguished Professor and Head of the Department of Medicine at the University of Oklahoma College of Medicine, we not only have professional ability second to none, but also the administrative guidance to coordinate the necessary components of a first rate Division of Immunology We have, as well, two unparalleled clinical resources for

immunological research in the Department of Rheumatology at Bone and Joint Hospital, and at the Oklahoma Allergy Clinic.

If this fund in the Community Foundation can grow large enough to endow a chair for a new Section of Immunology, and if enough funds can be raised to encourage an ongoing research program along with cooperative interdepartmental efforts, there is no reason why national or even international recognition might not be received by the University of Oklahoma Health Sciences Center during the lifetimes of the Founding Fathers of the Oklahoma City Community Foundation.

Nothing would offer a greater sense of pride and accomplishment than knowing that each contributor to this Allergy Research Fund played a part in such a milestone of accomplishment for all of humanity.

Knight Fund for 1978.

## The Roy P. and June W. Stewart Fund

Many of you will recognize the name of Roy P. Stewart from his many years at the Daily Oklahoman where he was city editor, Washington correspondent, roving feature writer, columnist and editorial writer. His "Country Boy" columns have been preserved as reference material in many libraries. Mr. Stewart is an author of numerous books and articles in national publications. Most recently, his book "Born Grown" — an Oklahoma City history, won the Western Heritage Award.

Mr. & Mrs. Stewart have three children: Ronald, of Oklahoma City, director of the Office of Community Affairs & Planning for the state; Dr. Roger Stewart, a geophysicist at Menlo Park, California, and Judith, Mrs. Gary Shank of Ft. Worth, who is director of

planning for the handicapped for the Ft. Worth Police Department.

Mr. Stewart is now executive director of the Oklahoma Advisory Council on Vocational-Technical Education. The Stewarts have designated World Neighbors and the OCU Library as beneficiaries of their fund in the Community Foundation

#### The O.K. Detrick Foundation, Inc. Fund

Otis K. Detrick was born in Clay City, Indiana, in 1883 and died in 1965 in Tulsa. He came as a young man from Indianapolis, Indiana, to Okmulgee in the early days of the oil industry and lived there from 1917 to 1931, was an independent oil producer, and formed the Detrick Corporation and the Chief Drilling Company.

In his will he set aside a group of oil properties to be administered by the O.K. Detrick Foundation. All income from the properties is used for charitable and educational purposes. Mr. Detrick's daughter, Dorothy Detrick Kendali, is the president of the Foundation, and the board is composed of Nina Detrick, his wife, and other family members.

The O.K. Detrick Foundation, Inc. Fund in the Community Foundation will benefit the School of Dance at OCU.
