Oklahoma City Community Foundation

The Oklahoma City Community Foundation is a nonprofit organization established in 1969 to receive and administer funds for assisting in the advancement of medicine, education, the arts, social services and civic organizations in the Oklahoma City area.

The Foundation does this by encouraging contributions, carefully managing donor gifts and conscientiously distributing funds for charitable purposes which will benefit the citizens of the community. An indication of the Foundation's success is the growing list of citizens and corporations which have made contributions to the Foundation, bringing total assets from \$45,299 in 1969 to over \$9 million at the end of fiscal 1981-82.

The Foundation has established several types of funding methods from which donors can choose for management and distribution of their contributions. While detailed information on these various funding methods is available through the offices of the Foundation, generally speaking they fall into two broad categories:

Undesignated Funds — The use of income and principal from these contributions (which can be made in any amount) is left entirely to the judgment of the Board of Trustees. This is the favored funding method of the Foundation, as the Trustees — selected for their insightful knowledge of the community and its philanthropic needs — can respond each year in light of current charitable needs. All contributions of less than \$500 must be undesignated. The law requires that at least one-half of the Foundation's assets be in undesignated funds.

Designated Funds — Donors may designate qualified, tax-exempt charitable entities to receive grants from the income or principal of these funds, so long as the Board of Trustees deems the charities appropriate to community needs. Contributions of \$5,000 or more may create a new individual fund; contributions of \$500 or more may be made to any existing fund.





The Board of Trustees

The Board of Trustees is the Foundation's governing body and also serves as the Distribution Committee. The Committee authorizes and controls all grants made from funds of the Foundation in accordance with the terms governing each fund. The nine members of the Board meet quarterly and serve for three-year staggered terms for a maximum of ten years. Each trustee was chosen for the position because of his integrity, leadership and understanding of the philanthropic needs of the Oklahoma City community.

The Fiscal Committee works to assist in managing the Foundation's investments, but each bank's trust department remains responsible for donor funds placed in their care. The annual earnings of each trust fund is passed on to the Board of Trustees for distribution of grants.

The Oklahoma City Community Foundation's Annual Report for the fiscal year February 1, 1981 to January 31, 1982 reflects generous support from donors. The Trustees understand this to indicate approval of the Foundation as an appropriate vehicle for philanthropy in Greater Oklahoma City. This agrees with the Foundation's basic purpose, defined from its inception in 1969, "to better provide for the charitable and educational needs of Greater Oklahoma City, Oklahoma and its vicinity."

The Annual Report also reflects the stewardship which the Trustees exercise in the management and disbursement of donors' monies. The Endowment Fund grew by \$846,824.00 in net contributions and by \$208,998.00 in earnings retained and added to the corpus of the Endowment Fund. The increase in total assets amounted to \$913,137.00. Disbursements for charitable and educational purposes were \$1,309,629.00. The composition of these disbursements in brief summary is:

62% (\$814,036.00) to agencies funded by name in the Endowment Fund

6% (\$80,000.00) in response to agency special requests

32% (\$415,593.00) from General Fund and Special Projects income in accord with the advice and suggestion of donors.

This exercise of stewardship the Trustees view as their primary responsibility.
