Staking A Claim



Located in Kerr Park, the statue honoring the pioneers of 1889 was used for the cover photo of the twenty-year book.

The publication of "A Twenty-Year Stake in the Community" marks the twentieth anniversary of the Oklahoma City Community Foundation. The twenty-year book features the history of the Community Foundation and compares it with the Land Run's Centennial.

The book focuses on the donors without whom there would be no Oklahoma City Community Foundation. All 301 Name Funds are listed with brief descriptions. Some Name Funds are illustrated by vignettes showing how an individuals' interests have been translated into gifts to the community through the Community Foundation.

The twenty-year book also lists more than 200 Designated Funds and the total distributions made to each during the past twenty years. Included at the end is an Annual Report for the Fiscal year ending June 30, 1989 which includes grants, distributions, and audited financial statements.

Production staff for the special report included Linda Garrett, layout and design, and Karen Browne, editorial and copywriting. Copies of the twenty-year book are available at the Oklahoma City Community Foundation.

Oklahoma City's New Pooled Income Fund

Oklahoma City Community Foundation has recently received approval from the Internal Revenue Service to operate a Pooled Income Fund. Donors can make a commitment of a charitable contribution yet retain a lifetime income interest. The unique type of investment fund will be managed by the four Fiscal Trustee Banks serving the Community Foundation.

The Pooled Income Fund is much like a mutual fund, but for the ultimate benefit of charity. Participating in the Pooled Income Fund requires a minimum contribution and entitles the donor to an immediate partial tax deduction. However, the gift does not go to charity right away. Instead, it is invested for the beneficiary, who can be the donor, a family member, or a friend selected by the donor.

The investment income is given to the beneficiary in quarterly payments — just as it would be with a standard mutual fund. When the income beneficiary dies, the investment is removed from the Pooled Income Fund and automatically converted into a separate, permanent fund for charity managed by the Community Foundation.

Donors to the Pooled Income Fund have several options when selecting the ultimate charitable beneficiary. The donor's remainder interest can be used to:

- establish a Fund which supports the Fund for Oklahoma City

- establish a fund that is restricted to a special interest of the donor such as scholarships, arts, or health care.

- establish an endowment fund for the benefit of a specific charity.

In each case, a Name Fund will be established in the name of the donor or

Trustees Approve \$78,600 in Grants

Fifteen grant requests that met the June 30, 1989 deadline were approved by the Oklahoma City Community Foundation Board of Trustees. Funds for these grants are generated by the Fund for Oklahoma City, the Knight Trust and the Scholarship Endowment. Funds distributed totaled \$78,600. The following organizations received grants:

Arcadia Historical Preservation Society, \$7,000 to preserve and restore the Round Barn in Arcadia. It is one of the oldest, unique structures in Oklahoma.

Crimestoppers, \$5,800 to educate 6th graders in four Oklahoma City school districts about drug abuse.

Greater Oklahoma City Tree Bank Foundation, \$5,000 for seedlings to replace trees being transplanted in the metro area.

Leadership Oklahoma City, \$4,000 to provide scholarships which will expand the program to include members beyond the more established corporate and nonprofit community.


Ballet Oklahoma, \$10,000 to underwrite the cost of sets and

costumes for the company's winter performance, "Valentine Suites".

Chopin Soclety of Mid America, \$1,000 to underwrite a concert given by White Eagle.

Cimarron Circult Opera Company, \$6,000 to support four performances of the opera "Snow White", which will be held in Oklahoma City area schools.

Edmond Fine Arts Institute, \$1,000 to support work shops offered to the community.



The Round Barn, built around 1898, will be restored by hard-working volunteers and a grant from the Oklahoma City Community Foundation. The collapse of the roof in June 1988 prompted the reconstruction.

Oklahoma Folklife Festival, \$5,000 to underwrite the folklife festival, "Traditions '89".

Deer Creek Public Schools, \$10,000 in matching funds for the first phase of a three-year project to create a computer education program.

Healing Hands Health Care Services, \$2,500 to purchase antibiotics and other medical supplies.

University of Oklahoma College of Nursing, \$15,000 to fund a continuing education program for nurses on care for the elderly.

Mental Health Association/International Photography Hall of Fame, \$2,000 to sponsor a joint project which is an exhibit, "Homeless

> in America", designed to draw attention to

the problem of homelessness. Neighborhood Services Organi-

zation, \$1,500 to complete and publish a survey of available single-room occupancy housing in

pancy housing in the central city for the homeless population.

Youth Services of Oklahoma County, \$2,800 for an architectural review of Cleveland School for a potential residential and counselling facility for juveniles and for classroom facilities of the Day Treatment program.

another named by him. Each year, when the earnings on the fund are distributed they are identified with the Name Fund.

The gift may be made in cash or marketable securities. The Pooled Income Fund is especially advantageous for individuals who own marketable assets that have increased in value. By contributing these assets the donors can realize a higher current income and avoid the capital gains tax that would be paid if the asset were sold.

Non-profit organizations can utilize the Community Foundation's Pooled Income Fund to build their own endowment funds. By working with donors who can utilize the Pooled Income, the charities can solicit planned gifts that will ultimately become part of the Designated Endowment Fund at the Community Foundation. By combining forces with the Community Foundation, non-profit groups in Oklahoma City can offer new charitable giving opportunities to their supporters.

Community Foundation Honored

The Oklahoma City Community Foundation has been selected by Oklahoma City Beautiful to receive the Non-Profit Award for Distinguished Service.

Criteria for the award is based on service for beautification. The Community Foundation was selected because of two grants which were made to Oklahoma City Beautiful.

The first grant was for the "We are Winners" program which educates elementary students about the environment. A centennial grant was given to "Make it Shine in '89". According to Sydney Dobson, "the project wouldn't have been done without the help of the Oklahoma City Community Foundation."

Oklahoma City Beautiful is not a strictly civic or cultural organization and therefore doesn't fall into a traditional category funded by foundations. The Oklahoma City Community Foundation was the first foundation to make a contribution to Oklahoma City Beautiful.

"The Oklahoma City Community Foundation stepped out ahead of all the rest of them, and for this we are eternally grateful," said Ms. Dobson.

Three other awards will also be given. Lawrence M. Jones and HTB, Incorporated will receive the Individual and Corporation for Distinguished Awards respectively. The Mayor's Cup recipient is the Kerr-McGee Corporation.

Six Designated Funds Established

Six organizations have newly established Designated Funds at the Oklahoma City Community Foundation. Operating somewhat like an independent endowment fund, a Designated Fund is an accounting of all contributions to the Community Foundation which have been designated by the donor to benefit a specific organization. The contribution becomes part of the permanent endowment of the Community Foundation, and the earnings are distributed to the organizations annually. After the initial fund is established, additions can be made by any donor in any amount.

The six new funds include:

City Arts Center, a multipurpose arts facility located at the Oklahoma City State Fairgrounds. The fund was started with an initial gift of \$100,000 from the Kirkpatrick Foundation.

Edmond Educational Endowment, a public-school foundation supporting the Edmond Public Schools. The initial gift of \$5,000 was given by the Kirkpatrick Foundation.

Guthrle Public Schools Teaching Award, funding for an award for an outstanding public school teacher in Guthrie. The fund was started by the two sons of Mary and Spencer Sessions in memory of their parents.

Oklahoma City Philharmonic Society, a new symphony orchestra in Oklahoma City. The fund was started with an initial gift of \$5,000 from the Kirkpatrick Foundation.

Civic Music Association, a thirty-five year old association which sponsors a classical music series each year. The fund was started with a \$5,000 contribution from the Kirkpatrick Foundation and matched by the Civic Music Association.

Metro Alliance for Safer Cities, operates two drug and alcohol recovery programs called First Step. The fund was started with a grant of \$5,000 from the Kirkpatrick Foundation which was matched by the agency.

1989 Designated Distributions Listed

Checks have been mailed to the 182 recipients of Oklahoma City Community Foundation Designated Fund earnings. On August 30, 1989 the Trustees of the Community Foundation approved a record earnings distribution of \$2,050,000. Almost one half of that went to agencies with Designated Endowment Funds at the Community Foundation.

The distributions are based on eight percent of the average monthly balance in the fund. A Designated Endowment Fund for a non-profit organization consists of the contributions to the Community Foundation which have been specifically earmarked by the donors to benefit that organization.

"The size of the check depends on the size of the fund; the more contributions received, the greater will be the yearly distribution," said Community Foundation Executive Director Nancy Anthony.
