The Community Foundation: Here to Help You Build an Endowment

Donors in Oklahoma, recognized nationally for their generosity, have made the non-profit agency endowment fund program at the Oklahoma City Community Foundation the nation's largest. Nearly \$45 million is managed for more than 250 different organizations in the Oklahoma City area.

The thousands who have supported individual endowment funds for agencies are examples who demonstrate that a single person can have a profound impact on the long-term support for a cause (see story on Florence Ogden Wilson that follows). Thanks to the power of compounding and a long time line, endowments can be major contributors to organizations' funding needs.

One Person's Gift

A gift to an endowment is a gift that keeps giving beyond the lifetime of a donor. It results from a vision, a donor's dream, to support a cause for perpetuity. The legacy of endowment donations is not lost at the Community Foundation. Donors continue to be recognized long after their last dollar was donated.

There are literally thousands of individual donor stories at the Community Foundation.


The story of Florence Ogden Wilson on page two shows the power one person – and the passage of time – can have on an agency endowment fund. Endowment building is not about a few large gifts. Rather, it is a process of encouraging donors to invest in the long-term viability of an organization.

In most of us, we believe, there is at least a little of Miss Wilson's dream to build a better community. And that's where building endowments begins. some other forms of charitable giving that fund ongoing operations or capital campaigns.

Donors to endowments expect and insist that their gifts provide perpetual funding for the causes they support. Stewardship of endowment assets requires policies for investment and distribution that preserve the capital base of the endowment, that produce growth in excess of inflation and that generate distributions for the intended cause or organization. It is important that financial management policies address both investment and distribution.

In the fall of 1989, the Community Foundation announced a distribution policy that is designed to permit funds to capitalize on good investment years as well as protect in the event of a low or negative return market.

The policy calls for a cash distribution of five percent of the average market value of the fund over the previous eight quarters. This policy takes into account the growth in the funds attributable to investment

n important part of the Community Foundation's service to designated endowment fund agencies and donors is facilitating gift planning and giving. For many agencies, especially those unaccustomed to dealing with planned giving procedures, these services can help provide opportunities for growing a fund.

The staff at the Community Foundation is able to help donors determine the method of charitable giving that provides for maximum tax advantages, current income if needed and the greatest long-term charitable benefit for the cause or organization.

Specifically, the Community Foundation is highly experienced in dealing with bequests for wills or trusts and the design and administration of charitable remainder trusts, charitable gift annuity contracts and gifts of appreciated securities. The Community Foundation's Web site, www.occf.org, provides sample trust documents and annuity contracts. If a donor wishes to receive additional information, the Community Foundation provides free, online access to the Planned Giving Design Center, the industry leader in supplying news and information on tax and estate planning. Donors and professional advisors have found a wealth of information at the PGDC site.

The Community Foundation seeks to make it simple and efficient to donate securities, oil and gas properties, life insurance, real estate, stock in closely held businesses or virtually any other security to an agency endowment fund. By handling all the administrative details, reporting and investment administration, the Community Foundation always tries to make growing an endowment easy for donors and agencies.

Florence Ogden Wilson's lasting gifts to the future of Oklahoma City

In the daughter of William Ranney Wilson, a reporter and drama critic for the New York Times. After the death of her mother, she and her brother went to live with relatives in Ohio and later with an aunt and uncle in Oklahoma City, Alice and William Fremont Harn. Mr. Harn had come to Oklahoma in 1891 as a federal prosecutor to deal with those accused of violating the rules of the territory. He acquired land and became a leading developer, donating the 40 acres along N.E. 23rd Street for the new Capitol. Although related only by marriage, Florence Wilson and her brother inherited much of the Harn land and estate in Oklahoma City.

After graduating from Vassar, she returned to Oklahoma City and served as a secretary to her uncle in his law practice. She was active in civic and church affairs, serving on many community boards and was the first female Trustee at Oklahoma City University. In 1971, she sold a tract of land to the State of Oklahoma, deeding a 10 percent interest to the newly formed Oklahoma City Community Foundation. The Community Foundation's share of the sale, \$49,972, was to benefit five organizations: Cowboy Hall of Fame, Oklahoma Zoological Society, YMCA, YWCA and the Allied Arts Foundation. Liberty Bank, as trustee of this gift, generously added \$28 dollars to make the total amount \$50,000 and the share to each organization exactly \$10,000. These became the first designated endowment fund gifts at the Oklahoma City Community Foundation.

In 1977 and 1978, Miss Wilson added \$1,000 to each of the five funds, making her total contribution to each fund \$12,000. She died on July 30, 1979 at age 90. Even though Miss Wilson made no more gifts to these funds, her contributions started funds that were added to by other donors. The total value of the endowment funds for these organizations now exceeds \$4 million.

Over the past 30 years, each \$12,000 gift by Florence Wilson has generated annual cash distributions of \$23,694 for the agencies, including \$1,323 in 2001. The total value of the gift is now almost \$25,000, or a total return of more than 300 percent on the initial gift. Since the Community Foundation started crediting investment performance to funds in 1989, the total return has averaged 9 percent per year.

Because of this endowment gift, we still remember Florence Wilson and her contributions to Oklahoma City. Her gift is still making a difference, more than 20 years after her death, and will continue to do so into the future. Miss Wilson's gift started a movement in Oklahoma City to build endowment funds to provide for the future of organizations about which she cared. The Designated Endowment Fund program and the agencies it serves are looking for the Florence Wilsons of 2001 whose gifts will endow the future of many more organizations.


OUR SERVICES: More Than Simply Managing Money

A lot of financial organizations will help a nonprofit organization manage its endowment funds. The Community Foundation provides excellent investment services and a whole lot more to help organizations build endowments and improve the quality of their services.

All agencies with funds at the Community Foundation are promoted through the Community Foundation Annual Report as well as special year-end mailings to donors. The Community Foundation web site, www.occf.org, has a listing for each agency and a link to its web site. This communication exposes agencies to many donors and funding opportunities for their programs.

The development staff of the Community Foundation is able to provide planned giving services to assist any organization in securing a gift or working with a donor to structure a trust or bequest. The Community Foundation can serve as Trustee for these trusts or administer charitable gift annuities which will benefit an agency's endowment fund. The Community Foundation also works with donors who want to make a gift of non-cash assets for agency endowments.

In addition to development assistance, the Community Foundation has special programs to help



agencies which participate in the endowment program. Capacity building grants address needs for long-range planning and technology development. Training programs provide opportunities for staff to further develop skills and to interact with peers in other organizations.

Technology assessments give agencies an opportunity to get free advice about computing equipment and needs.

Working with the Community Foundation is much more than an investment relationship, it is a partnership to help build endowments and to improve the quality of service to the community.

performance and allows distributions to increase during years of well-performing markets.

Since the policy change 13 years ago, the results have been dramatic. The value of a \$20,000 fund in 1989 would have grown to \$41,147 in 2001. Cash distributions of \$20,485 would have been provided. The total investment return would have been \$41,632. This year in particular has demonstrated the wisdom of the Community Foundation's investment and distribution policies. In spite of a poorly performing stock market, endowment funds that have been at the Community Foundation for two years or more will show a slight increase in cash distributions compared with 2000.

In addition, investment performance by the Community Foundation's general pool of designated agency endowment funds exceeded benchmark indices. The return on the pool was –5.65 percent, slightly better than the composite benchmark (65 percent S&P 500/35 percent Lehman Intermediate Government/Credit Index) average of –5.78 percent.

The better than average performance can be credited in part to the work of the Community Foundation's Investment Committee. The seven-member committee has responsibility for investment policy and manager selection. Performance of fund managers and portfolios are evaluated quarterly. The investment mix and fund managers are evaluated over the long term and adjustments are made when appropriate.

Throughout the investment and distribution policies and practices, the Community Foundation focuses on diversity of investments, capital preservation and protection against inflation through long-term growth. Over the long term – through both good times and bad – the policies are proven extremely effective. Funding for the Future is a publication for agencies that have endowment funds at the Oklahoma City Community Foundation.
