## A desire to help others

Most recently, hundreds of thousands of Oklahoma City residents were left without power during the ice storm of December 2007 as power lines toppled across the state.

The American Red Cross of Central Oklahoma quickly mobilized and responded to the emergency by opening a shelter at the Cox Convention Center in downtown Oklahoma City. Staffed by nearly 130 volunteers, more than 1,200 people sought refuge at the shelter during the eight nights it was open, each receiving a cot, blanket, comfort kit with hygiene items, access to showers, snacks and hot meals. A medical area was set up for residents with health problems.

## Great Gifts

It was a true community effort, with the Salvation Army providing toys for children and the Southern Baptist Relief Crew cooking meals and setting up a play area with trained staff. One little girl even celebrated her sixth birthday at the shelter, complete with presents and a "birthday muffin."

"Without our donors we would have no hope of fulfilling our mission. It is only through the generosity of our donors and volunteers that we are able to serve others," says Vince Hernandez, chief executive officer of the American Red Cross of Central Oklahoma.
