

On behalf of the Trustees and staff of the Oklahoma City Community Foundation it is our pleasure to share with you the 2011 Annual Report.

As a community foundation, we are committed to administering endowment funds, according to the donors' intent, so the funds provide an annual source of revenue while also encouraging the establishment of additional endowments and promoting philanthropy. During Fiscal Year 2011 we were pleased to welcome 63 new funds and \$17,041,555 in gifts. Total grants for the year were in excess of \$18.7 million.

We are very pleased to report that the investment performance on our pooled investments was 21.57 percent, the best performance in our history. Our Investment Committee along with our investment counsel does an outstanding job of monitoring our performance.

In addition to the list of donors, endowment funds and grants included in this report, on pages 10 and 11 you will find a highlight of activities and programs that occurred during the year.

Our activities and focus go beyond administering endowments. We continue to provide leadership and encourage collaboration on issues such as access to education and basic health care.

Through our Community Programs area, we awarded 52 discretionary grants for \$836,301 in Fiscal Year 2011. To better measure the impact of these grants, we implemented a new measurement and evaluation tool that should prove helpful to both us and the nonprofits who received the grants.

As always, our work would not be possible without the support of donors past and present. Please do not hesitate to contact us if you have any questions.

The Oklahoma Railway Museum Preserving Oklahoma's Railroad Heritage

The Oklahoma Railway Museum and its team of dedicated members truly epitomize the famous children's story *The Little Engine That Could*.

Armed with an unflappable "we think we can" mentality, the members have established the Oklahoma Railway Museum as an educational and interactive attraction in northeast Oklahoma City. Created in 1972 by a group of railroad enthusiasts, the Oklahoma Railway Museum collects and preserves artifacts that reflect the heritage of railroad and street rail transportation in the 19th and 20th centuries in Oklahoma. The nonprofit organization also promotes safe conduct around and near all railroad operations through its partnership with Oklahoma Operation Lifesaver, a public safety education program.

"We are a very interesting group, a total volunteer effort with no staff that has one common denominator, the love of railroads," explains Drake Rice, who is on the museum's board of directors. "One may not realize but the newest piece of rail equipment we use at the museum was built in the 1950s and requires lots of TLC to keep it rolling."

The museum's location at 3400 N.E. Grand Blvd. is much more than a museum of freight and passenger cars and even a steam engine; kids of all ages can ride a train every first and third Saturday of the month, April through August. The train rides cover a three-mile track and right-of-way maintained by the organization's members. The museum also offers special Halloween and Christmas train rides. In recent years, the museum has hosted the "Day Out With Thomas" event that features rides on a 15-ton replica of Thomas the Tank Engine, star of the popular *Thomas & Friends* children's series. It wasn't until 1999 that the organization had a physical location they could call its own. Several years prior, the members had manned several Union Pacific historic passenger fleets during a two-day event, netting enough revenue to eventually purchase the property on Northeast Grand Boulevard. Since 2000, the museum has grown from one operating locomotive to 10 locomotives, a 7,000-square-foot shop and a depot. Annually, more than 20,000 passengers enjoy a train ride at the Oklahoma Railway Museum.

In 2004, the organization established its charitable organization endowment fund at the Oklahoma City Community Foundation. Mr. Rice says the organization encourages all of its members to contribute to the endowment whether the gift is small or large.

Most recently, the Oklahoma Railway Museum participated in the 2011 Endowment Match Challenge that provided a dollar-fordollar match for endowments with fund balances below a certain amount. Between April 1 and June 30, the group raised \$5,000 thus increasing their endowment fund balance by \$10,000. The purpose behind the Challenge was not only to increase the fund balance but also attract new donors, says Nancy B. Anthony, executive director of the Oklahoma City Community Foundation.

"The wide participation by so many of the Oklahoma Railway Museum supporters should be an inspiration to many organizations who want to develop endowment fund support," Mrs. Anthony says.

Mr. Rice says the members are all in agreement that the endowment fund will help carry the organization forward. "The endowment is a way for us to continue to provide an opportunity for those visiting the museum and for future members to enjoy our love of railroads," he adds.

Coyle and Berry Families Helping Former Foster Care Children

The Oklahoma Youth With Promise endowment fund provides more than financial support for former foster care children in Oklahoma who are seeking post-secondary education. Just as important, it provides a source of encouragement for these children to succeed.

Vanessa Morrison became a ward of the court at age 13 and remained in foster care until she graduated from high school. And while the Oklahoma Department of Human Resources provides assistance for college expenses for former foster care children, it's the day-to-day living expenses that can often be a barrier to success for these students. That's when the Oklahoma Youth With Promise program can provide assistance.

Vanessa is just the type of student the Coyle and Berry families hoped to help when they created the Plaza Foundation Scholarship in 1988. At that time the families owned several retail shopping properties including the Nichols Hills Plaza. They asked their marketing consultant, Jean Lehr, to help them find a charitable cause to support and she recommended a scholarship for former foster care children. Nolan Coyle says the idea of helping these children continue their education and attain a college degree was just what the families were looking for.

In 1996, the families moved the scholarship fund to the Oklahoma City Community Foundation to establish a permanent endowment fund now named the Oklahoma Youth With Promise program. The families continue to support the program through gifts to the endowment and Nolan serves on the program's committee.

"The Oklahoma Youth With Promise program is unique in that we can monitor the needs and progress of the students receiving the funds and help them in specific ways along the path toward a college degree," he adds. "We are very proud of Oklahoma Youth With Promise and the help it provides students in accomplishing their goals. Seeing the determination in these kids from enrollment to graduation has been the greatest reward." To ensure the endowment fund will have the greatest impact, the Oklahoma City Community Foundation established relationships with state agencies to identify eligible former foster care children. In addition, annual distributions from other endowments to the Oklahoma Youth With Promise fund help ensure that the students' needs are met. Since 1996, the fund has assisted 332 individuals.

"A number of our unrestricted scholarship funds were specified to help students with financial need," says Nancy B. Anthony, executive director of the Oklahoma City Community Foundation. "There was no better way to utilize these funds than the Oklahoma Youth With Promise program."

The support Vanessa has received from the Oklahoma Youth With Promise program was never more important than in August of 2011. She came home from a study abroad program in Africa to discover her part-time job had been transferred to Tulsa.

"I was out of work for over a month, so I was really grateful for the assistance," she says. "Receiving this help over the years has meant so much to me. It's really about people wanting to make a difference and help change people's lives."

Vanessa will graduate from the University of Oklahoma in December of 2011 with a bachelor's degree in human relations and a minor in women and gender studies. Her career goal is to one day be a mental health therapist.

"Women need a strong role model, especially young girls," Vanessa says. "Just what I've gone through and how I've been able to survive, I just really want to help others."

And thanks in part to the Coyle and Berry families and the Oklahoma Youth With Promise endowment fund there's no doubt Vanessa will do just that.

Paula Sue Gabrish Honoring a Family Legacy

As a graduate and former member of the band at Moore High School, Paula Sue Gabrish says it was an easy decision to support the Moore High School Alumni Association Music Scholarship Fund at the Oklahoma City Community Foundation.

"I've always wanted to do something for my high school," says Paula Sue. "When my CPA advised me to make a charitable gift, I immediately thought of the music scholarship."

Paula Sue's ties to the Moore High School band began before she was born. In fact, Paula Sue, her father, her brother and her nieces and nephews have all played in the band at Moore High School.

"I attribute my involvement with the band to my dad," she says. "I made this gift in his memory."

After graduating in 1979, Paula Sue attended Rose State College where she earned two associate's degrees in accounting and business. She has been a legal instruments examiner for the Federal Aviation Administration Aircraft Registry for 29 years.

Recently, after inheriting oil and gas assets, Paula Sue's CPA advised her to make a charitable gift to help offset taxes. As a board member of the Moore High School Alumni Association, she says she knew about the group's desire to create a music scholarship endowment and thought it was a natural fit. In 2010, she made a significant gift to the music scholarship fund that supports an award for a graduating senior who was a member of the band or choral group and plans to pursue a music degree. It is only fitting that the first recipient of the award, 2011 graduate Lindsay Robbins, plays the flute, the same instrument Paula Sue played.

Formed in 1989, the Moore High School Alumni Association supports the school by providing scholarships and other services for students and graduates. The nonprofit organization has established a total of five scholarship endowments at the Oklahoma City Community Foundation to reward deserving graduates and help them attain postsecondary education.

Larry Haswell, treasurer of the association and also a former band member, says he has long envisioned creating a scholarship for band and vocal music students. With the high school's storied history of outstanding bands and choral groups it only seemed right that the alumni association honor this impressive tradition.

"Paula's generous gift to the music scholarship fund helped put into motion the alumni association's largest scholarship offering to date, doubling previous endowments," says Larry. "Paula's band experience has obviously inspired a willingness to give back in hopes that others will have a similar experience. Her support of this program honors her father and is a lasting tribute to her family."

Fiscal Year 2011: A Snapshot

The day-to-day activities of the Oklahoma City Community Foundation are guided by both the mission and vision statements of the organization. Below is a recap of the most recent fiscal year ending June 30, 2011.

Record Investment Performance

The 21.57 percent investment performance for the pooled investments for Fiscal Year 2011 was the best in the 18-year history of the pooled investment fund. In addition, it follows a return of 12.99 percent for Fiscal Year 2010 for a compounded total return for the pooled fund over the past two years of 37.4 percent. Oklahoma City Parks Study Spurs Discussion

For the past 20 years, the Oklahoma City Community Foundation has committed a great deal of time and grant dollars to public parks and lands in Oklahoma County. This commitment was started with a bequest that established the Margaret Annis Boys Trust in 1991. Specifically, the Margaret Annis Boys Trust has awarded more than 250 beautification grants exceeding \$2 million. Due to this level of commitment and investment, we commissioned a comprehensive study of the Oklahoma City Parks System. The study had the following three goals: assess the current park system with an emphasis on the role of parks in the municipal fiscal setting; assess the city's park system within the context of the seven measures of an excellent park system developed by the Trust for Public Land; and to conduct a review of the operational costs of the newly-renovated Myriad Botanical Gardens, the Bicentennial Park and the proposed MAPS 3 Central Park and how increases in park-related costs will be absorbed into the city's budget. The study findings were released in June 2011 and shared with Oklahoma City officials. Several meetings were held with city council representatives, staff from the planning and parks departments, the city manager's office and the Margaret Annis Boys Trust Committee. The clear consensus from the group was the need for a comprehensive parks plan which should be available in the spring of 2012.

iFund Program Helps Meet Current Community Needs

By utilizing unrestricted funds and several Field of Interest Funds, in February 2011 the Oklahoma City Community Foundation introduced the iFund grants program to help meet community needs in three specific areas: Access to Health Care,



Services for Elderly and Opportunities for Children. During the inaugural year, more than \$470,000 was granted to 25 nonprofit organizations. The iFund Program also provides a way for donors to experience the impact of charitable giving. Anyone can make a gift of \$25 or more to one, two or all three iFunds and we will combine those gifts with other funding and ensure that 100 percent of all gifts will be made to award grants. Our Mission: The mission of the Oklahoma City Community Foundation, a nonprofit public charity, is to serve the charitable purposes of its donors and the charitable needs of the Oklahoma City area through the development and administration of endowment and other charitable funds with the goal of preserving capital and enhancing value.

Our Vision: We value integrity, stewardship and collaboration. We strive to be enlightened leaders with a long-term perspective of community issues and opportunities, and we encourage and assist donors' philanthropy for the benefit of the community.

Revisions in Community Programs Area

Through our Community Programs area we are able to provide resources to nonprofit organizations including training, consultation and grants. Since 1997, these activities have been funded by discretionary funds and participation is limited to the more than 300 nonprofit organizations that have an endowment fund at the Oklahoma City Community Foundation. Beginning in Fiscal Year 2011, several changes were made to the grants portion including the introduction of the Basic Operational Grants and Sustainable Organization Support Grants. The Basic Operational Grants assist smaller nonprofit organizations with first-time organizational and administrative needs such as audits and strategic planning. The Sustainable Organization Support grants seek to strengthen the skills, abilities and resources of an organization so it can survive, adapt and thrive. In addition, a new evaluation and measurement tool was implemented so that both the organizations and the Oklahoma City Community Foundation can better measure the impact of the grant dollars.

Scholarship Endowment Area Continues to Grow

Scholarship and award funds remain a popular vehicle for donors. During Fiscal Year 2011, six endowment funds were established bringing the total number of scholarship and award endowments to 157. In addition, we administer a number of organization endowment funds that support scholarships for organizations and educational institutions. In all, 507 worthy students received a scholarship from an endowment at the Oklahoma City Community Foundation during the fiscal year. First Public Art for Automobile Alley Installed

In March 2011 we became the new home for the outdoor sculpture "Four Orbits." The 21-foot tall piece is located on the lawn south of the building.

The sculpture is Automobile Alley's first public art and is on loan to us from the Kirkpatrick Oil Company. The sculpture was originally installed at the company's headquarters.

"Four Orbits" was created by Charles O. Perry (1929-2011), a sculptor, designer and architect known for his large-scale, monumental pieces that reflect the mysteries of the universe and question the laws of nature. "Four Orbits" is a dark bronze with a dark, almost black patina that weighs approximately 5,000 pounds and is mounted on a 10-foot stainless steel base pole.

Enhanced Online Giving Service

For nearly 10 years, we have offered online giving as an easy and secure method for donors to make credit card gifts to endowment funds at the Oklahoma City Community Foundation. During Fiscal Year 2011, we enhanced this process by partnering with PayPal to process the gifts to make the experience easier and more convenient. Donors can visit www.occf.org/onlinegiving to make a direct gift to an endowment fund.

Funds, Gifts and Grants

During Fiscal Year 2011, 63 new funds and 17 new planned gifts were established. This compares to 53 and eight respectively in Fiscal Year 2010. In all, total new gifts received during the year were \$17,041,555. Total grants for the year were in excess of \$18.7 million. This amount includes annual distributions from charitable organization endowment funds of more than \$5.4 million, advised fund grants of nearly \$11.7 million as well as scholarship distributions, discretionary grants and program expenses.

2011 Endowment Match Challenge

Part of our mission is to encourage support for the permanent endowment funds we



administer. During Fiscal Year 2011 we provided an opportunity to those nonprofit organizations whose endowment fund balances were below a certain level to increase the fund by offering a dollar-for-dollar match. The match grants are for \$5,000, \$7,500 or \$10,000 depending upon the participating organizations' endowment fund balance as of Dec. 31, 2010. We will match all contributions made to the endowment fund between April 1, 2011 and Dec. 31, 2011. This is a great chance for these organizations to make contact with donors and increase their endowment which means increasing their annual distribution amount. More than 40 organizations signed up for the Challenge.

Special Donors

Special Donor endowments are established by families and individuals who have made a significant charitable commitment through the Oklahoma City Community Foundation. Special Donor designation recognizes total giving of \$500,000 or more to permanent endowments.

7-Eleven Stores Fund | 2010 ■

Established in honor of employees, the fund supports the Fund for Oklahoma City.

O. June Allen | 1987

The widow of oilman Featherstone H. Allen, Mrs. Allen left a bequest from her estate to support the Fund for Oklahoma City.

H.W. Almen/West OKC Rotary Scholarship Fund | 2004

Businessman H.W. Almen was a longtime member of the West OKC Rotary Club. A bequest in his estate left a \$1.3 million gift to the club to establish a scholarship program for Oklahoma students. The club used the bequest to create the endowment.

American Banjo Museum/Jack Canine Fund | 2008

Jack Canine is passionate about the banjo. The former owner of an Indiana-based manufacturing company, Mr. Canine helped to establish the American Banjo Museum that is now located in Oklahoma City. In 2008, Mr. Canine, who resides in Florida, made a \$5 million gift to establish this endowment.

Annie & Isaac Bloom Educational Scholarship | 2001

Esther Bloom was a generous yet anonymous supporter of Emanuel Synagogue. When she died in 1997, she left her estate to the synagogue with the request that a fund be established in her parents' memory and utilized for the education of the congregation's children.

Margaret Annis Boys | 1991

A \$1.5 million bequest from her estate created the Margaret Annis Boys Trust that is used for beautification projects in public parks, medians and school grounds in Oklahoma County. Read more on page 52.

Thomas & Patricia Dix Brewer | 1992

A native of Oklahoma City, Thomas Brewer lives in Springfield, Mo., and is a deacon in the Catholic church. His wife, Dr. Patricia Dix, is an obstetrician specializing in maternal-fetal medicine. Their gift of an insurance policy is established as an advised fund that supports the promotion and values of justice and peace.

W.H. Crocus Seeing Eye Dog Fund | 1998

An anonymous donor established this endowment after witnessing the relationship between a Seeing Eye dog and a blind man who worked in the same building. The donor admired the trust shared between the two and the independence the dog provided for the man. This fund supports the training and availability of Seeing Eye dogs for the visually impaired and is named for the first Seeing Eye dog sponsored by the fund.

Emanuel Synagogue | 2003

Congregation Emanuel was founded in Oklahoma City in 1904 and is a traditional, egalitarian congregation affiliated with The United Synagogue of Conservative Judaism. The trustees of the Emanuel Synagogue Endowment Fund transferred its assets to take advantage of the long-term oversight and investment opportunities available at the Oklahoma City Community Foundation. This was the first endowment established at the Oklahoma City Community Foundation to benefit a faith community.

Irene P. & Samuel F. Frierson Educational Trust | 1997

The fund was established by the Frierson Educational Trust to provide scholarships to students attending an Oklahoma college. Dr. Frierson was a native of Mississippi who practiced medicine in Oklahoma City and died in 1961. Scholarships are awarded through our Trustee Scholarship Initiative.

Edward King Gaylord Scholarship Fund | 1970

Mr. Gaylord, founder of the Oklahoma Publishing Company, established this endowment fund prior to his death and further funded it through a bequest in his estate. The fund supports scholarships awarded through the Trustee Scholarship Initiative.

Robert A. Herring Trust | 2006

The endowment was established through a bequest in Mr. Herring's estate to support medical research related to Parkinson's disease and genetic disorders. Mr. Herring was the long-time owner of the Chelsea, Okla. weekly newspaper.

G. Ed Hudgins Family Fund | 1989

Mr. Hudgins was a founding partner of the Oklahoma City architectural and engineering firm HTB, Inc. A graduate of Oklahoma State University, he established a fund to support donor advised distributions and a scholarship at the university's College of Architecture and Engineering.

William M. & Janet S. Johnson Scholarship Fund | 1987

Established through bequests from Mr. and Mrs. Johnson's estate, the fund supports an annual scholarship for a Minco, Okla., high school graduate. The fund also supports the Nurse Education Program, an initiative that works with area nonprofit hospitals to address the nursing shortage in critical care facilities. Mr. Johnson, a native of Minco, was a long-time employee of Gulf Oil.

Joan Kirkpatrick | 1972

The only child of John and Eleanor Kirkpatrick, Joan was chair of her family's private foundation and focused its resources on areas of personal interest such as animal welfare and the environment. She was generous with her time both as a volunteer and through her board service with several nonprofits. Prior to her death in 2009, Joan established several endowment funds to benefit her favorite animal welfare organizations.

John E. & Eleanor B. Kirkpatrick | 1969

Ten years after establishing a private foundation, the Kirkpatricks established the Oklahoma City Community Foundation in 1969 to provide opportunities for donors in the community to support charitable causes and organizations. Mr. Kirkpatrick served as the founding President for the first 10 years and again as a Trustee from 1985-91. Over a period of 20 years, the Kirkpatricks supported a challenge match program for charitable organizations with funds at the **Oklahoma City Community Foundation** to encourage donors to support and help increase the endowments. In all, the Kirkpatrick Challenges generated more than \$58 million in endowment assets for more than 230 organizations. Mrs. Kirkpatrick died in 1998 and Mr. Kirkpatrick in 2006. Lawton Retail Merchants Association | 1998

Through the operation of a credit bureau serving southwest Oklahoma, the Lawton Retail Merchants Association generated thousands of dollars of support for the Lawton area. The association was the primary funding source for the establishment of the Lawton Community Foundation, an Affiliated Fund of the Oklahoma City Community Foundation.

Edward P. & Norma Leslie Fund | 2004

Established by a bequest from the couple's estate, the fund supports a variety of the charitable interests they shared during their 62-year marriage. The fund also benefits the Fund for Oklahoma City. Mr. Leslie was an Oklahoma City businessman who spent more than 60 years in the insurance industry and demonstrated daily his commitment to community and service to others.

McGee Foundation Fund | 2001

The fund supports scholarships for first generation students and foster children through our Trustee Scholarship Initiative. Dean A. McGee was a co-founder of Kerr McGee and was one of nine original Trustees of the Oklahoma City Community Foundation. He and his wife Dorthea established the McGee Foundation in 1963. Their daughters Marcia and Patricia continue this scholarship support.

Bill & Sally McNutt Foundation | 2005

Janet McNutt transferred the assets of her late parents' private foundation to the Oklahoma City Community Foundation to establish an endowment to support the family's charitable interests. Bill McNutt was a businessman and attorney in Oklahoma City and Sally McNutt was an active volunteer. Although the couple relocated to Texas in the 1980s, they continued to support charitable interests in Oklahoma City.

Milton & Mary Meier Fund | 2005

Established by a bequest from Mrs. Meier's estate, this fund supports the Fund for Oklahoma City. In 1993, Mrs. Meier created the Lt. Felix Christopher McKean Fund in memory of her brother who was killed in World War II. A bequest in her estate established the following funds in honor and memory of the following family members: David Felix McKean, Felix Christopher McKean, Alice and Karl Meier, Christina Moore McKean and Mary and Christopher Moore.

Ruth Mershon Fund | 2001

Dr. Gary Moore Fund | 1999

A graduate of Oklahoma City University, Dr. Gary Moore dedicated much of his energy to giving back to the school. Dr. Moore had attended the school through the Great Plan program that sought to educate the country's next generation of scientists. Dr. Moore established a fund to support scholarships for liberal arts students and a second one to provide scholarships for students in the Dance and Arts Management program.

B.C. Clark Family Fund

Many Oklahomans know of B.C. Clark Jewelers thanks to their popular holiday jingle. What they may not know about is the family's philanthropic side.

In 1992, in celebration of the company's 100th anniversary, the Clark family established a permanent endowment fund at the Oklahoma City Community Foundation. At the time, B.C. Clark Jr. said establishing the fund was the best avenue for the family to give back to the community. Through the advised fund, the family recommends grants to a wide variety of charitable organizations.

B.C. Clark Jr., son of the company's founder, said the family believed it was important to give back. "We are pioneer Oklahomans; our roots are here," he said. "Oklahoma City has been good to us and we think this is the best avenue to do something for a number of charities."

From its simple beginnings as a watch maker in 1892 in Purcell, Indian Territory, B.C. Clark Jewelers operates three locations in Oklahoma City and is still owned and operated by the Clark family. Jim Clark, grandson of the founder, serves as a Trustee of the Oklahoma City Community Foundation.

"It's nice to know that future generations of the B.C. Clark family will make an impact on the community by recommending grants from the fund," Jim Clark says.

Donna Nigh Foundation | 1996

In honor of the former Oklahoma first lady's work on behalf of the state's developmentally disabled, her friends established the Donna Nigh Foundation in 1985. The foundation supports grants to provide adaptive equipment for those in group homes or individuals cared for by their families as well as other grants to benefit those diagnosed with mental retardation. In 1996, the foundation's assets were moved to the Oklahoma City Community Foundation.

Oklahoma City Jewish Community Foundation | 1999

Several funds were transferred by the Oklahoma City Jewish Community Foundation to the Oklahoma City Community Foundation in 1999. The earnings support the Jewish Federation of Greater Oklahoma City and a wide range of activities. Funds within the Oklahoma City Jewish Community Foundation include:

Clarence E. Page Fund | 1987

An aviation pioneer, Clarence E. Page established the Oklahoma Air Space Museum in 1980 and was the principal donor. Mr. Page, whose family made the 1889 Land Run, learned to fly as an Army pilot during World War I. During World War II, he conducted a primary flight training school at Cimarron Field (now Clarence E. Page Airport) and Mustang Field in El Reno. Mr. Page died in 1989. Distributions from several funds he established continue to support the aviation exhibits at Science Museum Oklahoma.

William T. Payne Fund | 1976

From humble beginnings, William T. Payne would go on to become a wellrespected and successful oil man. Known for his business acumen and integrity, the founder of Big Chief Drilling lived by the adage "the price we pay for living on Earth is what we do for others." Mr. Payne died in 1981. Today, three generations of his family continue to recommend grants from the fund.

F. M. & Thelma Petree Fund | 1977

A graduate of the University of Oklahoma Law School, F.M. "Pete" Petree married Thelma in 1939. In addition to establishing Liberty Mortgage, Mr. Petree chaired the executive committee of Oklahoma City University and helped the university recover from near bankruptcy in the 1970s. He served as a Trustee of the Oklahoma City Community Foundation. Contributions support Oklahoma City University and other charitable organization endowments.

Winona S. Presley Fund | 1999

After graduating from Oklahoma A&M College, Winona Shingleton Presley worked as a teacher. Her love of education motivated her to establish endowments for the Oklahoma 4-H Foundation, the University of Central Oklahoma and Oklahoma City University. A bequest from her estate supports the Fund for Oklahoma City and continues her strong support of education.

Ramsey Family/Blue & Gold Sausage Fund | 1979

While working as an agricultural education teacher and FFA advisor in the 1960s, Mr. Ramsey began processing the students' pigs into sausage that the students would sell to fund activities. The idea of selling a high quality sausage product as a fundraiser took off and the family soon founded Blue & Gold Sausage Co. The Ramseys started an advised fund in 2001 to perpetuate their support of agricultural education scholarships and programs.

Edna Ratliff Fund | 2001

Edna Ratliff moved to Oklahoma City in the 1920s to attend business school and soon began working for Liberty National Bank. One of the first female trust officers in Oklahoma, she worked for the bank for 48 years before retiring in 1976. Contributions from her estate, including mineral interests, support several health-related organizations and other community needs.

Records-Johnston Family Foundation | 1979

Ross Johnston established the foundation in honor of his father, Willard Johnston, who made the 1889 Land Run and started the first commercial bank in Shawnee. Ross joined his father in the banking business after World War I. He later entered the mortgage business, helping to establish Midland Mortgage Company, now known as The Midland Group headed by his son-in-law, George J. Records. Contributions support Casady School and other education and scholarship funds.

Bert R. Reed Jr. Fund | 1998

An Oklahoma City native, Bert Reed Jr. was an attorney and businessman. Mr. Reed was an active participant and supporter of the Downtown Kiwanis, Oklahoma Zoological Society and Oklahoma City Museum of Art. He created an advised fund in 1998 and further funded it through a bequest in his estate in 2008.

A. Tom F. & Gladys Seale Fund | 1986

Although childless, Tom and Gladys Seale loved children. Tom was an engineer with Kerr McGee and designed the first off-shore drilling rig. Prior to his death in 1989, the couple established an advised fund to support several youthserving organizations. Mrs. Seale died in 2006. A bequest in their estate ensures the fund will continue to support these organizations and the cardiac care unit at St. Anthony Hospital.

Willie Elizabeth Shipley Scholarship Fund | 1981

The fund was established through a bequest in Miss Shipley's will to provide scholarships for students who reside in western Oklahoma. Miss Shipley was a longtime employee of the Oklahoma State Senate. Awards from the fund are made through the Oklahoma Youth With Promise program that assists Oklahoma foster children seeking a post high school education.

Scott & Geneva Smith Fund | 2000

As graduates of Central High School, Scott and Geneva Smith were made aware of the Oklahoma City Community Foundation through the Central High School Alumni Association Scholarship Fund. Their fund supports donor advised distributions.

Southwest Homebuilders Association Fund | 1999

The Southwest Homebuilders Association represents more than 50 homebuilders who build a project house each year and donate a portion of the profits from the sale to a charitable organization or project. The proceeds from the sale of property established the fund that benefits charitable organizations in south Oklahoma City and the Wendell Stewart Scholarship Fund, an endowment the group established in honor of an association member.

Olive May Steward Fund for Human Services | 1994

The fund was established through a bequest from Miss Steward's estate to serve the basic welfare and health needs of Oklahoma City residents. Ms. Steward was the daughter of Judge Seymour and Mary Grace Steward and worked for many years at First National Bank.

Walter Stiller Fund | 2002

The fund was established through a bequest from Mr. Stiller to support the Fund for Oklahoma City. An Oklahoma City native, Mr. Stiller retired as treasurer of Macklanburg-Duncan. A member of Zion Lutheran Church since 1918, he lived to the age of 99.

Tom A. Thomas Jr. Fund | 1979

Tom A. Thomas Jr. flew combat missions in World War II and was a collector of World War II aircraft. Along with his brother, he operated Thomas Concrete in Oklahoma City and was active in the pre-cast concrete business for 26 years. Gifts from trusts established in his estate benefit more than 40 charitable organizations.

Thomas Utterback Fund | 1999

Established through a bequest in Mr. Utterback's will, the fund supports projects in south Oklahoma City and scholarships. Mr. Utterback was a longtime banker in Oklahoma City and an active supporter of the Capitol Hill area.

R.A. Young Foundation Fund | 2007

Born in Indian Territory in 1904, R.A. Young was an astute businessman who loved Oklahoma. He was one of the founders of TG&Y, a chain store company that had more than 920 U.S. locations when it was sold in the 1960s. Through a bequest in his estate, a portion of his private foundation was transferred to the Oklahoma City Community Foundation and supports annual grants to charitable organizations including the public library in his hometown of Kingfisher.



Ruth Mershon

Ruth Mershon

A physician for 47 years, Ruth Mershon was a caring and well respected anesthesiologist. Born in 1924 in Pushmataha County, Okla., Dr. Mershon earned her Kelvin Zhang medical degree from



the University of Oklahoma in 1949 and worked first in Hutchinson, Kan. before returning to Oklahoma City in 1975. She was raised in a family environment that valued education and the arts; her grandfather was a college professor and her mother was an avid reader and advocate for public libraries.

In planning her estate, Dr. Mershon directed that all remaining assets of her retirement accounts be used to establish an endowment at the Oklahoma City Community Foundation. Since her death in 2000, the Ruth Mershon Fund has supported the areas Dr. Mershon had most cared about such as the arts, animals and education.

For Kelvin Zhang, a 2006 graduate of Edmond North High School, Dr. Mershon's generosity meant he could focus on his studies while attending North Carolina State University.

"One burden many students face, especially out-of-state students, is the financial aspect of paying for college," he says. "Receiving the Ruth Mershon Scholarship definitely helped ease my stress in paying for college." Kelvin graduated from college in 2010 and is now employed as a manufacturing engineer.

Donor Affiliated Endowments: Family Funds

Donor Affiliated Funds are permanent endowment funds with fund balances in excess of \$500,000. The Donor Affiliated Funds listed on pages 16-20 operate under a set of organizing documents and structure including fund trustees approved by the Oklahoma City Community Foundation Board of Trustees. The trustees listed with each fund served during Fiscal Year 2011.



Albers Family Affiliated Fund | 2006

Both graduates of John Marshall High School, Paul and Leigh Ann Albers returned to Oklahoma City in 2007. After graduating from West Point in 1972 Paul was involved in military and other government service for many years, much of the time overseas. In 1991, he and two former colleagues founded a defense technology and homeland security oriented company that within 15 years grew to have over 500 employees. Leigh Ann graduated from the College of Nursing at the University of Oklahoma in 1978 and was active in nursing in Oklahoma City until 1995 when she and Paul were married. Paul's company was acquired by a large defense contractor in late 2006. The couple established the Albers Family Affiliated Fund to support organizations and causes important to their family. The first grant from the fund established the Donald Albers M.D. Endowed Chair at the University of Oklahoma College of Medicine, Department of Urology, to honor and recognize Paul's father. Dr. Albers practiced in Oklahoma City and was an adjunct faculty member at the college.

Bob & Nancy Anthony Family Affiliated Fund | 1999

When Nancy Anthony joined the Oklahoma City Community Foundation as Executive Director in 1985, she and her husband Bob established an advised fund. They added to it each year and established additional funds for their four daughters, Elizabeth, Christine, Suzanne and Katie B., as each one reached high school. With an additional gift in 1999, the funds were combined to create the Anthony Family Affiliated Fund that continues the family's charitable interests and allows their daughters to experience charitable giving and civic responsibility firsthand.

William E. & Margaret H. Davis Family Affiliated Fund | 1987

Bill and Margaret Davis founded the William E. Davis and Sons food distribution business in the 1950s as a family enterprise and it remained so until it was sold in 1986. All six of the Davis children were involved in the business's management and development. The family established the William E. and Margaret H. Davis Family Affiliated Fund in 1987 to continue the family's tradition of supporting local charities and causes. The fund was the first Affiliated Fund established at the Oklahoma City Community Foundation and over the years has made more than \$1 million in grants to charitable organizations.

Reaching Our City

Each day, the staff and volunteers at Reaching Our City (ROC) work to ensure Oklahoma City's poor are provided food, job training, access to health care and childcare. On average, 1,250 people are provided emergency food relief each month that equates to more than 56,000 pounds of food.

Individuals and families seeking aid first meet with a volunteer that will act as their advocate and will identify resources for job placement, training, community support and health care. By collaborating with Variety Care, a community health center, ROC can offer health care to qualified clients. The organization's Child Development Center cares for more than 80 children whose parent or parents are in training for job placement. ROC also provides a coordinator to schedule free legal advice for clients through a partnership with Legal Aid Services of Oklahoma. ROC employs a staff of 40 and utilizes the assistance of more than 400 volunteers.



Volunteers with Reaching Our City shop the organization's food pantry as they fill grocery orders for low-income clients.

Kevin Rodgers, ROC executive director, credits the generosity of support from donors such as the Robert D. and Blanche H. Gordon Family Affiliated Fund as key resources for ROC's impact. "The Gordon family, and others like them, are a constant and generous reminder that we are stronger and better when we work together, when we re-connect to our neighborhoods and the families and children that make them," he says. "As a consequence, every dollar is multiplied, every loaf of bread is shared and every new friendship is a building block."



The Everett Family Affiliated Fund | 1993

Dr. Mark Allen Everett established a private foundation in 1960 to support his passion for the arts in Oklahoma. In 1993, Dr. Everett moved the private foundation to the Oklahoma City Community Foundation, continuing to support the arts, dance scholarships and music programs which he started at several local arts agencies and universities. Dr. Everett, a retired professor at the University of Oklahoma (OU) College of Medicine, also established the Mark R. Everett Scholarship for the benefit of a medical student in honor of his father, the former dean of the college, and the Alice Everett Cello Scholarship in honor of his mother. In addition, Dr. Everett used assets of a charitable remainder trust to create a fund in memory of Michael Adam Everett to assist in the education and treatment of youth with serious mental disorders. Although Dr. Everett died in 2006, his charitable legacy continues to support his motto of "having fun doing good."

Robert D. & Blanche H. Gordon Family Affiliated Fund | 1993

Robert Gordon graduated from Cornell University with a degree in petroleum geology and served in the U.S. Army during World War II. The Gordons moved to Oklahoma City in 1950 with the Ashland Oil Co., where Mr. Gordon served in positions from junior geologist to vice president until 1976 when he retired and became an independent petroleum geologist. The Gordon Family Affiliated Fund supports religious, educational and social service organizations in which Bob, Blanche and their children, Holly and Peggy, have a long-term interest. Mr. Gordon died in 2004 but his family continues to support local charities.

In 1950, he joined the Kirkpatrick Oil Company as one of its first employees. In 1957, Raymond and his wife Bonnie formed Bonray Oil Company and began a lifetime involvement in the oil and gas industry in both Oklahoma and on the national level. Mr. Hefner was a Trustee and Treasurer of the Oklahoma City Community Foundation. Prior to Mr. Hefner's death in 2001, the couple and their children, Vici Heitzke, Brenda Baldwin and Richard Hefner, established the fund to support their charitable interests.

So when the couple talks about enriching the social, cultural and educational opportunities for their neighbors, they think on a global level. Through their fund, the couple recommends grants to support a wide variety of projects and programs. They are ardent supporters of the Oklahoma Citybased World Neighbors, an organization that educates citizens of developing countries around the world on how to become self-sufficient and improve their lives as well as women's rights groups in third world countries. Local grants help support animal rescue organizations, educational institutions, the Oklahoma City Philharmonic, the Oklahoma City Zoological Society, and other charitable and civic organizations. "Our fund gives us so much pleasure," Claudia explains. "We are able to focus on supporting the groups we want without having to worry about the administrative details. It really is a simple and easy way to make a visible impact on the causes about which you are passionate."

The Love Family Affiliated Fund was established by the couple in 1999 to support their family's charitable goals. The Love Family Affiliated Fund is an important benefactor of many Oklahoma City charities.

Fifty years later, Ditch Witch equipment, designed and manufactured in Perry, is used worldwide. The Malzahn Family Affiliated Fund, which includes the Malzahn children, Don, Pam and Leasa, continues the family's tradition of generosity and civic responsibility. Recent grants to the Perry Public Schools have included funding for upgrading the auditorium's sound and lighting system and to purchase smartboards, computers and wireless infrastructure for all the schools.

Giddy Up 'N Go

In 2011, the Lawton Community Foundation endowment awarded a grant to Giddy Up 'N Go, a charitable organization that provides physical, occupational and speech-language therapy to children and adults with special needs through therapeutic horseback riding.

Established in 1992, the Lawton-based program helps individuals with disabilities build strength, improve posture and balance and develop self confidence through a dedicated team of physical therapists, riding instructors, experienced volunteers and specially trained therapy horses. Giddy Up 'N Go established a Charitable Organization Endowment at the Lawton Community Foundation in 2000.

The recent grant helped to provide needed repairs and improvements to the horse stalls, as well as free riding lessons for low-income families, says Nancy Arntz, board president.

Using the assets from the sale of its hospice operations, the Hospice Foundation of Oklahoma created an endowment fund to support palliative patient care throughout Oklahoma. Through the fund, the Hospice Foundation board has supported a survey conducted by the University of Oklahoma's College of Nursing to gauge the public awareness of hospice care. The fund trustees have also awarded a grant to the Senior Law Resource Center to provide individual assistance to people wishing to complete advance directives for healthcare.

Mr. Cleary died in April of 2011, but his ongoing support and passion for the Oklahoma City Philharmonic will ensure that the community will never again be without symphonic music.

After spending eight years with BF Goodrich, Joe opened his own business, Joe Esco Tire Company, in an abandoned filling station in downtown Oklahoma City. Sue was involved in numerous civic and charitable activities and was active in their two children's activities. She loved to sing and dance and Joe loved to dance with his beloved "Susie." Jack died in 1996 and following Martha's death in 2010 a bequest in the couple's estate funded the John and Martha Norris Estate Fund at the Oklahoma City Community Foundation. The endowment supports the Fund for Oklahoma City, which helps to fund various community and grant programs including the Literacy is For Everyone (LIFE) Initiative that provides opportunities for children and adults to read, write and speak English at a functional level.

A recent LIFE grant provided parenting tool kits for the Putnam City Public Schools Foundation Early Birds program, which gives hands-on guidance to parents of children ages birth to 5 to help better prepare their children for kindergarten.

Pearl Nieminen Palo was proud to be the daughter of Finnish immigrants. A native of Chicago, Pearl, known to her family as Helmi, graduated from Northwestern University. She taught high school English and French before moving to Oklahoma City in 1958 with her husband, Ernie. Once settled in Oklahoma City, Pearl became very involved with her church, First Presbyterian, where she initiated a social program for seniors and an afterschool tutoring program. She also taught French at Hoover Middle School. Both she and Ernie were enthusiastic amateur photographers and were active in the Oklahoma City Camera Club. Pearl remained proud of her heritage throughout her life; the couple and their two daughters frequently hosted Finnish students and visiting dignitaries.

Pearl died in October of 2009. When her estate was settled in August of 2010, the Oklahoma City Community Foundation received a gift that established the Pearl Palo Fund that will benefit several charitable organizations designated by Pearl.

Clyde Riggs

An Oklahoma City native and graduate of Classen High School, Clyde Riggs started his own construction company at the age of 25. Specializing in commercial construction, Clyde Riggs Construction has grown into a successful contracting company with projects across the country.

Outside of his work, Clyde enjoyed a variety of recreational activities, especially racing. In the 1960s, he helped introduce go-kart racing tracks to Oklahoma City and in 1979, he participated in the Cannonball Baker Sea-to-Shining Sea Memorial Trophy Dash, also known as Cannonball Run. Clyde's team finished seventh among 45 teams participating in the unofficial, cross-country car race.

But Clyde's greatest love was riding bicycles. He took cycling trips to Europe and California and was a staple at fundraising cycling events throughout Oklahoma. In 2010, Clyde died at the age of 75 in a bicycling accident.

Clyde also enjoyed volunteering his services for a number of charitable organizations including Rebuilding Together OKC, which helps to rebuild and repair the homes of low-income seniors to ensure they are safe and warm. He also made regular charitable contributions to the group's Charitable Organization Endowment fund at the Oklahoma City Community Foundation. Thanks to Clyde's kind support, Rebuilding Together OKC can rely on the endowment fund for annual income in perpetuity.

"Clyde's favorite saying was 'life is good' and he made life good for so many of us," says Valerie Aubert, executive director of Rebuilding Together OKC.



with a bachelor's degree in mechanical engineering. After serving in the U.S. Navy, Sig followed in his father's footsteps becoming president of the Oklahoma Paper Company (OPACO). He later sold the OPACO building as part of the Bricktown redevelopment plan and enjoyed telling friends that his company became right field of the new downtown ballpark. Sig worked as a commercial real estate broker with Spradling Real Estate until his death in 2010.

An avid golfer, he won two high school championships and qualified for the National Amateur Golf Tournament. A founding member of the Oklahoma City Golf Commission, Sig contributed significantly to the development of the city's public golf system, says Mike Cassady, chairman of the commission. He also served as president for a number of nonprofits including Temple B'nai Israel, the Jewish Federation of Oklahoma City, the Hillel Foundation at the University of Oklahoma and the Oklahoma Art Guild and was a board member of the Oklahoma League for the Blind, now NewView Oklahoma.

After Sig's death, his wife Helene and family established the Sig A. Harpman Jr. Memorial Fund at the Oklahoma City Community Foundation to benefit causes that were important to him.

J.B. Schuelein

A 25-year resident of the Mesta Park Historic District in central Oklahoma City, J.B. Schuelein believes it is the perfect example of an inner city neighborhood. He cites the turn-of-the-century architecture, the diversity of its residents and the common goal they all share of preserving and caring for their neighborhood. A major feature of the neighborhood is Perle Mesta Park, a 2.6-acre public park located at Northwest 18th Street between North Shartel and Lee avenues.

In 2003, J.B. and other residents developed an improvement plan for the neighborhood. "We had two big agenda items; one was replacing aging sidewalks and the other was establishing an endowment fund at the Oklahoma City Community Foundation," J.B. says.

Also high on the list was enhancing the park. J.B. credits park improvements to the sweat equity and generosity of residents, a good relationship with the Parks Department and several beautification grants from the Margaret Annis Boys Trust at the Oklahoma City Community Foundation. The result of all this collaboration is a park that is becoming the social center of the neighborhood. "It really brings people together," J.B. explains. "It's very rewarding for all of us to see it utilized and people enjoying it."

J.B. retired as administrator of the Oklahoma Water Resources Board in 2006. Not only is he active in his own neighborhood association where he's served in nearly every leadership role, he also volunteers his time with other nonprofits including Neighborhood Alliance of Oklahoma City, Oklahoma City Beautiful and Cimarron Alliance. Since 2003, J.B. has been a regular donor to the Mesta Park Neighborhood Association endowment fund.

Girl Scouts-Western Oklahoma

They may be best known for their annual Girl Scout Cookie Sale, but Girl Scouts-Western Oklahoma offers year-round programming for nearly 12,000 girls K-12th grade in 39 counties. In addition to the troop activities and camps, the organization offers outreach programs for girls held in juvenile detention, substance abuse rehab centers, five government housing communities and to teen mothers at an alternative school.

Other pathways to Girl Scouting today include STEM (Science, Technology, Engineering and Math) LEGO Robotics teams, Outdoor Education and Camping, High Adventure Teams, opportunities to travel the globe and more.

In Girl Scouts, girls are encouraged to make real changes in their communities and the world through the Girl Awards program. Girls can earn the Bronze, Silver and Gold Awards as part of their leadership experience by initiating community service projects. The



Girl Scouts-Western Oklahoma serves nearly 12,000 girls in 39 counties.

Gold Award is the highest honor a girl can earn in Scouting. Receiving the Gold Award can result in college scholarships and even a higher rank in the military.

Girl Scouts-Western Oklahoma was formed in 2008 when two councils merged: Red Lands Council and Sooner Council. Girl Scouts was first organized in central and western Oklahoma in 1935. In 1978, the organization established its charitable organization endowment fund at the Oklahoma City Community Foundation. During Fiscal Year 2011, the endowment fund received several grants from Advised Funds that allowed the organization to continue troop activities at several public housing sites.

Oklahoma City Boathouse Foundation

The Oklahoma River is becoming a thriving attraction thanks to the vision and efforts of the Oklahoma City Boathouse Foundation. In just a few short years, Oklahoma City is becoming known around the world for its river and river sports.

The Oklahoma River has been the site of numerous national and international racing events and festivals and has sparked the creation of rowing teams at area universities. The river was named an official U.S. Olympic and Paralympic training site. The Oklahoma River currently has three boathouses and the Chesapeake Finish Line tower. Additional improvements scheduled as part of the MAPS3 plan include permanent grandstands and lighting and a whitewater rafting and kayak center.

The mission of the foundation is to develop and operate programs and facilities at the river that not only attract competitive teams but also offer residents an alternative to fitness activities. Current foundation initiatives include youth outreach, adaptive rowing for the visually impaired and community programs for rowing, kayaking, running and cycling. In addition, the foundation operates the OKC National High Performance Center that provides training for Olympic hopefuls in rowing and canoe/kayak.

In 2007, the Oklahoma City Boathouse Foundation endowment fund was established at the Oklahoma City Community Foundation. During Fiscal Year 2011, the endowment fund received grants from several Advised Funds.

Charitable Organization Endowment Program

During Fiscal Year 2011, five nonprofit organizations established permanent endowment funds as part of our Charitable Organization Endowment Program. These new endowment funds are designated by a \blacksquare on pages 34-41. Through the Charitable Organization Endowment Program we administer endowment funds for more than 300 nonprofit organizations. As of June 30, 2011 the fund market value for these endowment funds was \$153.6 million and annual distributions to the organizations exceeded \$5.4 million.

Oklahoma Shakespeare in the Park

What started during the summer of 1985 with a free outdoor performance of Shakespeare's "Twelfth Night" has grown into one of the state's premiere outdoor theatre companies. Oklahoma Shakespeare in the Park began its summer productions at Hafer Park in Edmond before moving to the campus of the University of Central Oklahoma. By 2007, the company had relocated its summer productions to its current site at the Myriad Gardens Water Stage in downtown Oklahoma City.

In addition to its summer season, Oklahoma Shakespeare in the Park hosts staged readings as well as productions in cooperation with Oklahoma City University's theatre department. The organization also brings the Bard of Avon's works to life through Shakespeare Live!, an actor residency program where actors introduce students to Shakespeare and his world in an interactive and understandable method. Its touring productions bring the romance, drama and comedy of Shakespeare's works to communities across the state as either full productions or performances and seminars.

The organization established its endowment fund at the Oklahoma City Community Foundation in 1989.

Arcadia Historical & Preservation Society

The preservation of the Round Barn and other notable sites in Arcadia is the mission of the Arcadia Historical & Preservation Society. Built in 1898 and located along historic Route 66, the Round Barn was in major decline and its enormous 60-foot roof had collapsed by 1988 when a group of volunteers began a four-year restoration process. The effort was helped by a Fund for Oklahoma City grant in 1990.

The organization received a National Preservation Honor Award in recognition of the outstanding craftsmanship and perseverance in the restoration efforts. Round barns began populating farms in the 1880s and were promoted as a more costeffective alternative because they required fewer materials to build and provided more volume-to-surface ratio than the standard barn design.

Once home to livestock and farm implements the two-story Arcadia barn and the surrounding grounds are now the site of events and celebrations. In order to ensure its future, the dedicated group of volunteers established an endowment fund in 1993.

The organization is working to increase its endowment balance by participating in the 2011 Endowment Match Challenge where gifts are matched dollar-for-dollar up to a certain level. The match is a way for the organization to reach out to donors and encourage support for its endowment fund. Neighborhood Services Organization

For more than 90 years, Neighborhood Services Organization (NSO) has been assisting the community's low income and homeless population by providing housing solutions, life skills programs and basic health care services.

The faith-based organization offers several housing programs that provide transitional and supportive housing to homeless families, single women and young men. The goal of each program is to help the clients become self-sufficient so they are able to transition to permanent housing. In addition to offering individual case management, NSO partners with different agencies to provide the clients access to parenting and literacy classes.

NSO offers basic health care services at its two Women, Infant and Children (WIC) clinics to an average of 100 clients a day. These clients receive nutritional education and supplemental foods at no cost during the critical phases of child growth and development. NSO also operates a full-service dental clinic that charges a minimal fee for its services. Dental services include exams, x-rays, fillings, cleanings, extractions, partials and dentures. The dental clinic serves an average of 4,000 clients a year.

The NSO endowment fund at the Oklahoma City Community Foundation was established in 1982.

"Our endowment fund provides critical resources that help with our administrative overhead costs," says Anne Harber, NSO communications director. "Without it, we wouldn't be able to operate our housing programs that provide people in need a place to live."

OK Chorale

For more than 70 years OK Chorale has been entertaining audiences in central Oklahoma with the four-part harmony singing style known as barbershop. The chorus comprises nearly 60 men who range from teens to men in their 90s who share the common love of singing and entertaining audiences and are dedicated to preserving and promoting the art of barbershop. Annual performances include fall and Christmas programs and concerts at numerous other venues including the annual Festival of the Arts in Oklahoma City.

In 2002, the OK Chorale established an endowment fund at the Oklahoma City Community Foundation and since then has worked to increase the fund's balance. The nonprofit organization is participating in the 2011 Endowment Match Challenge, a dollar-for-dollar match offered to organizations with lower fund balances. The goal of the match is to have the organizations seek out donors and encourage support for their endowment fund.

The organization is excited about building its endowment fund so it can help support the group's Young Men in Harmony program that works with school choral programs, says Jeffrey Sykes, director for OK Chorale.

"We have held workshops at schools and look to do more of the same in the future," he adds. "We have had students that join our organization after graduating because they see a chance to continue their enjoyment of singing and performing."

Dean A. The Salvation Army

In addition to helping out with the day-to-day needs of the area's homeless and low-income residents, The Salvation Army Central Oklahoma Area Command is also a first-line disaster response organization. During 2011, the organization provided food, shelter and spiritual and emotional care to several hundred victims following the May 24th tornadoes in Canadian County. In addition to the immediate needs, The Salvation Army provides funding for uninsured expenses for families and individuals rebuilding or repairing their property.

The organization utilized its mobile feeding canteen during the late summer wildfires in central Oklahoma. Over a twoday period, staff and volunteers served more than 1,160 meals and nearly 650 snacks to the firefighters and others who were providing support.

The Salvation Army Central Oklahoma Area Command also responds to other major disasters where mass feeding is necessary such as floods, snow and ice storms and hurricane evacuation shelters. The Salvation Army partners with the City of Oklahoma City during disasters.

The organization's permanent endowment fund at the Oklahoma City Community Foundation was established in 1971.

YMCA of Greater Oklahoma City

For the YMCA of Greater Oklahoma City, annual distributions from its endowment fund at the Oklahoma City Community Foundation allows the organization to provide direct financial assistance to primarily low-income families in all aspects of its programming, says Damon King, director of financial development.

The YMCA of Greater Oklahoma City was established in May of 1889, just one month after the famous land run. Throughout its history, the organization has evolved its programs to adjust to the current needs of the community. Today, programs are offered through 10 branch locations and more than 20 program sites. The organization provides child care, resident and day camp opportunities, programs for seniors, afterschool programs, aquatic and sailing programs, health and wellness education, teen leadership programs and military support programs.

The organization's endowment fund was established in 1971. In subsequent years, other endowment funds were established to benefit the following branch locations: Downtown, Eastside and Northside. In addition, an endowment fund was established in 1983 to benefit Camp Classen located in the Arbuckle Mountains in southeast Oklahoma and is the site for summer and day camps as well as weekend retreats for families. Science Museum Oklahoma

Established in 1958 as the Oklahoma Science and Arts Foundation by John E. Kirkpatrick, the mission of the Science Museum Oklahoma has evolved into one focused on science and technology. Housed in what was originally the Kirkpatrick Center located in northeast Oklahoma City, the museum features traveling exhibits as well as permanent exhibits and activities.

A regular highlight at the museum is Science Live, 40-minute science demonstrations that are both entertaining and educational. A longtime feature is the Dome Theatre that includes a 70-foot diameter dome screen, the first of its kind in Oklahoma that nearly surrounds the audience.

The annual distribution that benefits the Science Museum Oklahoma is actually a compilation of distributions from three separate Affiliated Funds established specifically for the Kirkpatrick Center, the Oklahoma Air Space Museum and the Omniplex. The annual distribution from the endowments provides both tangible and intangible benefits for the museum, says Don Otto, museum president.

"The annual distributions allow us to confidently budget for expenses that are vital to the museum's operations but are not easily funded by other sources. It also facilitates long-term planning by providing a reliable revenue stream in an often unreliable world."

iFund Grants Make Immediate Impact

Launched in 2011, the iFund Grants program allows the Oklahoma City Community Foundation to more effectively utilize the resources available through a number of Field of Interest Funds that were established either from funds created to support a nonprofit organization that no longer exists or created by donors to support a particular charitable interest.

Health Care

What are the three iFunds?

Access to Health Care supports grants to provide basic and preventative health care including mental and dental care to individuals without access to care.

Opportunities for Children supports grants to provide for children who are physically or economically disadvantaged.

Services for Elderly supports grants to help our older citizens stay safe and well in their homes.

Who's Eligible to Apply for an iFund Grant?

iFund grants are available to 501(c)(3) nonprofit organizations headquartered in central Oklahoma that provide direct services to children, the elderly or individuals in need of basic and preventative health care.

During 2011, grants were awarded to the following 25 nonprofit organizations for a total of \$471,472.

Access to Health Care iFund:

- **Community Health Centers** to support the Sharing Optical Solutions program that provides eye exams and eye glasses to 600 low-income clients.
- **D-DENT** to support the Pilot Project for Veterans that provides comprehensive dental care to 125 military veterans.
- Health Alliance for the Uninsured for the Super Saturdays for Women, a quarterly event held at four free clinics in the metropolitan area that provide free gynecological examinations for uninsured or under-insured women.
- Mental Health Association of Central Oklahoma for expansion of the TeenScreen Program, a mental health and suicide risk screening program for students attending central Oklahoma high schools.
- **St. Anthony Hospital Foundation** to start a Weight Management Clinic at St. Anthony Hospital in conjunction with the Oklahoma State Medical Society.
- Variety Care to support a Patient's Assistance Fund to meet medical needs of low-income patients and to provide diabetes education.

Dr. Edith King Mental Health Scholarship

Dr. Edith G. King could be called a pioneer in the mental health field in Oklahoma. After graduating from the University of Iowa, she moved to Oklahoma City and obtained a doctorate in clinical psychology. In 1981, she became the first executive director of North Care Community Mental Health Center, an outpatient behavioral health center serving low-income families in Oklahoma City. She was also one of the original volunteers at the Compassion Center, a family assistance center that provided counseling services to victims and their families following the 1995 bombing of the Murrah Federal Building. After her retirement as chief psychologist and chief of forensic services at the Oklahoma County Crisis Intervention Center in 1999, Dr. King continued her pursuit for better mental health services for the underserved population and in 2002, she helped establish the first mental health court in Oklahoma.

In 2002, the Dr. Edith King Mental Health Scholarship was established at the Oklahoma City Community Foundation to honor her leadership and commitment to the field of mental health services in Oklahoma. The scholarship benefits a graduate student pursuing a degree to further a career in mental health services.

"Receiving this scholarship reminds me of the great impact service has on others," says Chase Bailey, the 2011 recipient of the award.

Chase will receive his master's degree from the University of Oklahoma in 2013, with plans to pursue a doctorate and is interested in working as a family counselor.

Community Programs

Community Programs provide an opportunity for the Oklahoma City Community Foundation to address specific opportunities within the metropolitan area and to provide leadership and support in finding how to best address these opportunities. We seek collaborations and partnerships to create a real impact within the community.

During Fiscal Year 2011, Community Programs included these four focus areas: Charitable Organization Endowment Program, Literacy Is For Everyone (LIFE) Initiative, Parks & Public Spaces Initiative/Margaret Annis Boys Trust and the Trustee Scholarship Initiative. Each focus area works with a committee of Trustees and community volunteers who provide valuable input. A list of Community Programs committees for Fiscal Year 2011 can be found on page 55.

Fund for Oklahoma City

Primary funding for the Community Programs activities is provided through the Fund for Oklahoma City, a compilation of unrestricted funds that donors have supported for nearly 40 years. Donors who support the Fund for Oklahoma City are investing in the future of our community and providing an opportunity for the organization to address issues as they arise both now and in the future.





Oklahoma Visual Arts Coalition is a statewide nonprofit organization that promotes the visual arts through publications, educational programs and annual exhibitions such as Momentum.

Oklahoma Visual Arts Coalition

A Sustainable Organization Support (SOS) grant awarded in Fiscal Year 2011 helped the Oklahoma Visual Arts Coalition (OVAC) with strategic planning to improve governance structure and staff planning, as well as to develop a program evaluation model.

Established in 1988, the organization supports visual artists living and working in Oklahoma and promotes public interest in the arts through education, exhibitions and events. OVAC programs such as its Artist Survival Kit Workshop are designed to support artists' careers, helping them develop business structures to create and distribute their artwork and providing opportunities for them to connect with the public.

OVAC established its Charitable Organization Endowment in 1998.

Charitable Organization Endowment Program

Through our Charitable Organization Endowment Program area we provide resources to nonprofit organizations including training, consultation and grants. Since 1997, these activities have been supported by the Fund for Oklahoma City and other discretionary endowments. Participation is limited to the more than 300 nonprofit organizations that have a permanent endowment fund at the Oklahoma City Community Foundation.

New Grants Programs Introduced in Fiscal Year 2011

Effective Fiscal Year 2011, several changes were implemented to the grants portion of the Charitable Organization Endowment Program. The new Basic Operational Grants assist smaller nonprofit organizations with first-time organizational and administrative needs such as audits and strategic planning. For more established organizations, the Sustainable Organization Support grants seek to strengthen the skills, abilities and resources of an organization so it can survive, adapt and thrive. In addition, a new evaluation and measurement tool was implemented so that both the organizations and the Oklahoma City Community Foundation can better measure the impact of these grants. 2011 Endowment Match Challenge

During Fiscal Year 2011 we provided an opportunity to those nonprofit organizations with endowment fund balances below \$50,000 to increase the fund's value by offering a dollar-for-dollar match. The match grants offered were \$5,000, \$7,500 or \$10,000 depending upon the participating organizations' endowment specific fund balance as of Dec. 31, 2010; for instance those organizations with lower endowment fund balance were offered a \$10,000 match opportunity. In all, 47 organizations chose to participate in the match. All contributions made to the endowment fund between April 1, 2011 and Dec. 31, 2011 will be matched up to the limit of the matching gift offered.

Training, Programs and Resources

Each month, our electronic newsletter, "E-News," is distributed to all participants of the Charitable Organization Endowment Program. Each issue provides a digest of timely information, links to resources and a schedule of upcoming grant deadlines and training opportunities.

With partner Cole & Reed PC, every quarter we host "Lunch for 2," a free workshop that provides two hours of continuing education credit for certified public accountants who work for or with nonprofit organizations.

Legacy Giving is a dedicated portion of our website – www.occf.org – that features planned giving resources for both donors and professional advisors. We encourage nonprofit organizations to utilize the resources available at Legacy Giving. We also work directly with organizations' staff and boards to discuss planned giving with their donors.

Online Giving Services

An updated online giving service was launched in 2011 at www.occf.org/donate. In partnership with PayPal, we are able to process all credit card gifts to endowment funds. It's a secure and convenient way for donors to support one or more organization's endowment fund. We also include a link to the online giving service on each organization's page as part of Central Oklahoma Charities, our online directory of nonprofit organizations.

Literacy Link of Eastern Oklahoma County

Although Frances completed school through the 11th grade, she left with virtually no reading or writing skills. Her lack of skills were a serious barrier for this grandmother, resulting in her inability to read or order from a restaurant's menu. Frances is now gaining control of this life-long obstacle by attending one-on-one tutoring provided by Literacy Link of Eastern Oklahoma County.

Since 1986, Literacy Link of Eastern Oklahoma County has offered free tutoring services to anyone 18 years or older with the goal of helping them learn to read and write well enough to function effectively in day-to-day living. Housed in the Midwest City Public Library, the nonprofit organization offers the tutoring at no cost to the students and volunteers donate their time as tutors. During Fiscal Year 2011, Literacy Link received a LIFE Initiative grant to purchase educational materials and assist with the development of a new website.

Literacy Is For Everyone (LIFE) Initiative

According to the National Assessment of Adult Literacy, 43 percent of Oklahoma adults – more than 1 million people – currently function at the lowest two literacy levels. Researchers have found that these adults find it difficult to understand the instructions of medical care providers, read consent forms and understand labels on prescription bottles.

In 2005, the Oklahoma City Community Foundation Trustees established the Literacy Is For Everyone (LIFE) Initiative to address illiteracy in our community and to provide all adults and families in the metropolitan area the opportunity to learn to read, write and speak English at a functional level. The LIFE Initiative works closely with literacy providers in the community to provide resources and funding for training, materials and support. Through the initiative, the Oklahoma City Community Foundation works to increase community awareness for literacy skills and integrate literacy into social services, job training and other rehabilitation programs.

Get Reading Oklahoma

Launched through the Initiative in 2009, Get Reading Oklahoma offers two free television series, TV411 and GED Connection, for adults seeking to improve their reading, writing and math skills and to prepare for the GED exam. The programs air on the Oklahoma Educational Television Authority (OETA) and are also available through Cox's FreeZone section of On DEMAND, channel 1, Cox Channel 18 in Oklahoma City, Cox Channel 21 in Tulsa and as streaming videos at www.getreadingoklahoma.org.

Additionally, GED Connection and TV411 workbooks, teachers' guides and DVDs are available for literacy programs, GED providers and public libraries throughout the state. Individuals seeking literacy services or who want to volunteer can call the toll free telephone number 1-888-OK2Read (1-888-652-7323) and be connected with literacy programs in their community.

Oklahoma City Metro Literacy Coalition

In 2008, the Oklahoma City Community Foundation joined together with the Junior League of Oklahoma City, United Way of Central Oklahoma, Community Literacy Centers and the Retired Senior Volunteer Program (RSVP) to form the Oklahoma City Metro Literacy Coalition to address the increasingly low literacy levels in the metropolitan Oklahoma City area. Today the coalition membership has grown to include both literacy providers and nonprofit organizations that work together to increase awareness of literacy issues and support literacy programs throughout the area. Additionally, the coalition helps to provide access to literacy services for all learners through programs and resources available at www.okcliteracycoalition.org.

Ralph Ellison Library

In 2011, the Parks & Public Spaces Initiative helped with improvements to the grounds at Ralph Ellison Library. Located at Northeast 23rd Street and Martin Luther King Avenue, the library had recently been remodeled and library officials contacted the Oklahoma City Community Foundation for help with a comprehensive landscaping plan prior to its reopening.

"Our main goal in working with the library was to improve visual appeal of the grounds while keeping long-term maintenance costs at a minimum," says Brian Dougherty, director of the Parks & Public Spaces Initiative.

In addition to landscape improvements and plantings, outdoor bicycle racks were also added for use by library-goers.

Margaret Annis Boys Trust/ Parks & Public Spaces Initiative

Established in 1991, the Margaret Annis Boys Trust together with the Parks & Public Spaces Initiative provides support for beautification projects in parks, medians, schools, neighborhoods and other public lands throughout the Oklahoma City metropolitan area.

Park System Study

In 2010, the Oklahoma City Community Foundation Parks & Public Spaces Initiative commissioned a comprehensive study of the Oklahoma City Park System focusing on the following goals:

- 1) Assess the current park system with an emphasis on the role of parks in the municipal fiscal setting.
- 2) Assess the city's park system within the context of the seven measures of an excellent park system developed by the Trust for Public Land.
- 3) Conduct a review of the operational costs of the newly-renovated Myriad Botanical Gardens, the Bicentennial Park and the proposed MAPS 3 Central Park and how increases in park-related costs will be absorbed into the city's budget.

Conducted by the Oklahoma City University Economic Research & Policy Institute, the study was completed in the spring of 2011. The Margaret Annis Boys Trust Committee together with Oklahoma City council representatives and other city officials identified the need for a comprehensive parks plan that should be available in the spring of 2012. The park system study is available to the public at www.occf.org/documents/ParksStudyfinal.pdf.

Public Library Beautification Program / Clean and Beautiful Schools

In response to the interest of several Metropolitan Library System locations, a beautification program was established in 2010 through the Parks & Public Spaces Initiative to support the landscaping and maintenance of several library grounds. The program is modeled after Clean and Beautiful Schools, which has helped to improve the landscape of more than 130 elementary school grounds in Oklahoma County since 2000. In addition to supporting landscaping projects, the Oklahoma City Community Foundation offers professional guidance and free maintenance workshops for groundskeepers. In Fiscal Year 2011, three public libraries participated in the program: Midwest City, The Village and Ralph Ellison Library.

The Margaret Annis Boys Arboretum at Will Rogers Gardens

Improvements to the Margaret Annis Boys Arboretum at Will Rogers Gardens continue to progress and include a new entryway as well as paved walking trails to make the arboretum more accessible. Partially funded by a grant from the Margaret Annis Boys Trust, the project is scheduled for completion in the spring of 2012.

Historic Drought Limits Plantings

The extreme drought conditions throughout the state have limited plantings during Fiscal Year 2011. Total precipitation in Oklahoma from Oct. 1, 2010 through Aug. 31, 2011 was 14.12 inches less than normal, according to data from the National Weather Service. While many beautification grants were approved and awarded, the projects were placed on hold until the fall and winter when conditions will be more favorable for planting.

Since the start of the Trustee Scholarship Initiative, the Oklahoma City Community Foundation has held a variety of recognition events for recipients of the Community Foundation Scholars and Foundation of Promise Scholars awards, their guidance counselors and parents or guardians. These well-attended events have been held at a variety of venues. In 2011, we felt it was important to host the recognition in our building so the students better understood where the awards originated. We held two luncheons over a two-day period to accommodate the students and their guidance counselors.

Trustee Scholarship Initiative

In 1998, the Trustees of the Oklahoma City Community Foundation decided to make post-secondary education of students in central Oklahoma a priority and the Trustee Scholarship Initiative was established. Through the initiative, five scholarship programs have been created, as well as the Central Oklahoma Guidance Counselor Network. To date, the initiative has awarded more than \$4 million in scholarship funds to more than 2,600 students in central Oklahoma.

Scholarship Programs

The **Community Foundation Scholars** program rewards good students who are also good citizens. Recipients are students who might not otherwise qualify for awards based solely on academic standards. In 2011, 83 scholarships of \$1,500 each were awarded.

The **Foundation of Promise** program provides scholarships for students who will be the first in their family to attend college. Recipients complete a series of college preparatory activities, including summer employment. In 2011, 58 students received a \$1,500 Foundation of Promise Scholars award.

The **Oklahoma Youth With Promise Scholars** program assists students who have graduated from high school while in Oklahoma's foster care system and wish to pursue a post-secondary education. Most recently, 53 students were awarded scholarships through this program.

The **Non-Traditional Scholars** program helps adults re-entering the educational system by working through several agencies to identify adults who have completed one educational program and possess the ability and desire to advance to another program. Mentoring support is provided to recipients through their sponsoring organizations.

The **Nurse Education Program** was established in 2003 to address staffing challenges facing the area's nonprofit hospitals. Scholarships are provided to nurses employed at any of five participating hospitals who are seeking an associate or bachelor's degree in nursing. For the 2010-11 academic year, 39 students received scholarships through this program.

Central Oklahoma Guidance Counselor Network

The Central Oklahoma Guidance Counselor Network provides training and support for high school guidance counselors at 51 public and private high schools in central Oklahoma. During Fiscal Year 2011, the network hosted two training workshops. Additionally, Community Foundation Scholar awards are presented to each high school with a participating guidance counselor.

Oklahoma City benefited in immeasurable ways from the efforts and energy of Jackie Carey. Mrs. Carey, who died in 2010 at the age of 81, served on the Oklahoma City Council 1984-94, a period when city leaders were putting together the elements that would become the Metropolitan Area Projects (MAPS) master plan. Then Mayor Ron Norick selected Mrs. Carey to head the committee that would determine what projects to include on the ballot. She remained an enthusiastic supporter of MAPS that is credited with sparking more than \$2 billion in investment in downtown Oklahoma City. Mrs. Carey was also a strong advocate for the arts and helped to ensure the renovations of the Civic Center was part of MAPS.

In addition, she served as president of both the Junior League of Oklahoma City and the Oklahoma City Arts Council and was a founding director and president of Leadership Oklahoma City. Mrs. Carey also carried the distinction as being the first female to serve as a Trustee for the Oklahoma City Community Foundation, a role she held from 1979-84.

Administrative Expenses

Economies of scale and a close watch on the budget enable the Oklahoma City Community Foundation to operate at an extremely low cost. We attempt to balance the level of services provided with a cost conscious approach and are pleased to report that administrative expenses over the last five years have averaged just under 40 basis points (40/100 of 1 percent).

Investment Management Costs

The low cost and efficient operation of our investment program benefits all endowments. We accomplish this by using active managers and index funds in a way that maximizes the opportunity for adding value but keeps the costs low. For Fiscal Year 2011, our costs of investments was 37 basis points (37/100 of 1 percent) compared to more than 100 basis points for the average mutual fund or active equity fund manager who requires a large minimum account.

Summary of Our Distribution Policy


Since 1989, the Oklahoma City Community Foundation has employed a distribution policy that is designed to permit funds to capitalize on good investment years as well as protect in the event of a low or negative return market. The experience of the past few years, where returns were on both extremes of investment performance, has proven the wisdom of a policy which stabilizes the effects of market conditions on distributions from an endowment.

Cash distributions from a majority of the endowment funds of the Oklahoma City Community Foundation are based on a spending policy that calls for distributing 5 percent of the fund's average market value. The remaining investment return is left with the fund to add to the value, which protects the future distribution stream from inflation. The annual distribution from the fund is more predictable because the amount is not tied to current income, which fluctuates due to shifts in market conditions, but is based on a rolling 12-quarter average of the fund's market value, adjusted for additional contributions.

There is general consensus among large educational and institutional endowment managers across the country that an amount close to 5 percent of the average market value is a safe amount to spend and still provide protection for the principal. The 5 percent figure is based upon an estimate of two factors over time: market return and inflation. A conservative prediction of average market return in a balanced fund over time is 8 percent. It is widely expected that inflation will average 3 percent over time. This leaves 5 percent to spend while still protecting the fund's value for the future. The Investment Committee's focus on long-term fund growth allows for a bias to equities in the asset allocation. The 5 percent spending rule allows growth to occur even if there are no additional contributions to the endowment fund.


Total Percentage of Gifts by Type of Fund

Assets by Type of Fund



Since July 1, 1998, the Oklahoma City Community Foundation has used an investment management structure that includes the oversight provided by a strong Investment Committee and employs a style-based investment manager system. The Investment Committee allocates assets to specific investment styles and hires investment managers to manage that particular style.

Investment Committee

The Committee is comprised of current Trustees and community leaders who are highly knowledgeable about investment decisions. Investment counsel is provided by Hotchkiss Associates LLC of Chicago, Ill.
