Gifts to Advised Funds by Dec. 31 Provide 2012 Deductions

With the uncertainty of what 2013 holds in regard to charitable tax deductions, donors may want to consider making a year-end gift to an Advised Fund at the Oklahoma City Community Foundation. Making a gift by Dec. 31 provides two opportunities: receiving a 2012 charitable tax deduction and making grant recommendations in 2013 and beyond. We recently had a donor make the equivalent of what he considered was 10 years of charitable gifts to establish an Advised Fund. By doing so, he avoided the expected cut or cap on deductions for charitable contributions in 2013 and can enjoy recommending grants at a later time.

Your Options

We offer three Advised Fund options. The Legacy Fund is a permanent endowment fund and the Gift Fund is a completely spendable fund. Both require minimum gifts of \$10,000 and are invested in our general investment pool. The Express Fund requires a minimum gift of \$1,000 and is completely spendable but receives no investment performance.

Assets We Accept

Under current law, a donation of assets that have appreciated often qualify for a deduction at full market price, thus eliminating capital-gains tax on the appreciation. In addition to cash and appreciated stocks, we accept a variety of gifts including real estate, business-related assets, oil and gas interests and life insurance.
