2012 Scholarship Match Challenge Results

We are proud to administer the state's largest independent scholarship program. This time of year our scholarship staff is busy processing scholarship applications that will be awarded this spring. In the academic year 2012, the program funded more than \$1.4 million in scholarships and awards to 707 students.



To further strengthen the program's impact, in 2012 we offered a match challenge to the scholarship endowment funds and 75 took us up on the offer. Gifts received between March 31 and Dec. 31 were included in the match and when the last gift was counted, the results were impressive. We received gifts from more than 560 donors that increased the endowments by a total of \$731,177. A special thanks to those of you who made a gift or gifts during the challenge. The idea of offering match challenges can be credited to our founders, John and Eleanor Kirkpatrick. They understood that challenges not only helped to increase endowment fund balances but also attracted new donors. IRA Charitable Rollover for 2013

The tax law recently passed by Congress included an extension of the IRA charitable rollover through Dec. 31, 2013. The rollover allows tax-free distributions of up to \$100,000 per taxpayer, per taxable year from an IRA held by individuals age 70 $\frac{1}{2}$ years or older. Workshop held for Guidance Counselors

Since 1998, our Trustee Scholarship Initiative has provided scholarships in central Oklahoma to good students who are good citizens, and we have also provided training for their high school guidance counselors. The program has grown to include 51 high schools in central Oklahoma. Twice a year, the schools' counselors participate in a free, one-day workshop that features presenters who provide the latest on college admissions, financial aid and other related topics. On Jan. 31, more than 60 counselors attended a workshop held at the Intergenerational Computer Center on the campus of Oklahoma City University.
